# Uniqueness problem for meromorphic mappings with truncated multiplicities and few targets ${ }^{(*)}$ 

Gerd Dethloff and Tran Van Tan ${ }^{(1)}$


#### Abstract

In this paper, using techniques of value distribution theory, we give a uniqueness theorem for meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$ with truncated multiplicities and "few" targets. We also give a theorem of linear degeneration for such maps with truncated multiplicities and moving targets.

Résumé. - Dans cet article, on donne un théorème d'unicité pour des applications méromorphes de $\mathbb{C}^{m}$ dans $\mathbb{C} P^{n}$ avec multiplicités coupées et avec «peu de» cibles. On donne aussi un théorème de dégénération linéaire pour des telles applications avec multiplicités coupées et avec des cibles mobiles. Les preuves utilisent des techniques de la distribution des valeurs.


## 1. Introduction

The uniqueness problem of meromorphic mappings under a condition on the inverse images of divisors was first studied by R. Nevalinna [8]. He showed that for two nonconstant meromorphic functions $f$ and $g$ on the complex plane $\mathbb{C}$, if they have the same inverse images for five distinct values then $f \equiv g$. In 1975, H. Fujimoto [3] generalized Nevanlinna's result to the case of meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$. He showed that for two linearly nondegenerate meromorphic mappings $f$ and $g$ of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$, if they have the same inverse images counted with multiplicities for $(3 n+2)$ hyperplanes in general position in $\mathbb{C} P^{n}$, then $f \equiv g$. Since that time, this problem has been studied intensively by H.Fujimoto ([4], [5] ...), L. Smiley [11], S. Ji [6], M. Ru [10], Z. Tu [12] and others.

[^0]Let $f$ be linearly nondegenerate meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$. For each hyperplane $H$ we denote by $v_{(f, H)}$ the map of $\mathbb{C}^{m}$ into $\mathbb{N}_{0}$ such that $v_{(f, H)}(a)\left(a \in \mathbb{C}^{m}\right)$ is the intersection multiplicity of the image of $f$ and $H$ at $f(a)$.

Take $q$ hyperplanes $H_{1}, \ldots, H_{q}$ in $\mathbb{C} P^{n}$ in general position and a positive integer $l_{0}$.

We consider the family $F\left(\left\{H_{j}\right\}_{j=1}^{q}, f, l_{0}\right)$ of all linearly nondegenerate meromorphic mappings $g: \mathbb{C}^{m} \longrightarrow \mathbb{C} P^{n}$ satisfying the conditions:
(a) $\min \left\{v_{\left(g, H_{j}\right)}, l_{0}\right\}=\min \left\{v_{\left(f, H_{j}\right)}, l_{0}\right\}$ for all $j \in\{1, \ldots, q\}$,
(b) $\operatorname{dim}\left(f^{-1}\left(H_{i}\right) \cap f^{-1}\left(H_{j}\right)\right) \leqslant m-2$, for all $1 \leqslant i<j \leqslant q$, and
(c) $g=f$ on $\bigcup_{j=1}^{q} f^{-1}\left(H_{j}\right)$.

In 1983, L.Smiley showed that:
Theorem A. - ([11]) If $q \geqslant 3 n+2$ then $g_{1}=g_{2}$ for any $g_{1}, g_{2} \in$ $F\left(\left\{H_{j}\right\}_{j=1}^{q}, f, 1\right)$.

For the case $q=3 n+1$ in $[4],[5],[6]$ the authors gave the following results:
Theorem B. - ([6]) Assume that $q=3 n+1$. Then for three mappings $g_{1}, g_{2}, g_{3} \in F\left(\left\{H_{j}\right\}_{j=1}^{q}, f, 1\right)$, the map $g_{1} \times g_{2} \times g_{3}: \mathbb{C}^{m} \longrightarrow \mathbb{C} P^{n} \times \mathbb{C} P^{n} \times$ $\mathbb{C} P^{n}$ is algebraically degenerate, namely, $\left\{\left(g_{1}(z), g_{2}(z), g_{3}(z)\right), z \in C^{m}\right\}$ is included in a proper algebraic subset of $\mathbb{C} P^{n} \times \mathbb{C} P^{n} \times \mathbb{C} P^{n}$.

Theorem C. - ([4]) Assume that $q=3 n+1$. Then there are at most two distinct mappings in $F\left(\left\{H_{j}\right\}_{j=1}^{q}, f, 2\right)$.

Theorem D. - ([5]) Assume that $n=2, q=7$. Then there exist some positive integer $l_{0}$ and a proper algebraic set $V$ in the cartesian product of seven copies of the space $\left(\mathbb{C} P^{2}\right)^{*}$ of all hyperplanes in $\mathbb{C} P^{2}$ such that, for an arbitrary set $\left(H_{1}, \ldots, H_{7}\right) \notin V$ and two nondegenerate meromorphic mappings $f, g$ of $\mathbb{C}^{m}$ into $\mathbb{C} P^{2}$ with $\min \left\{v_{\left(g, H_{j}\right)}, l_{0}\right\}=\min \left\{v_{\left(f, H_{j}\right)}, l_{0}\right\}$ for all $j \in\{1, \ldots, 7\}$, we have $f=g$.

In [5], H.Fujimoto also gave some open questions:

+ ) Does Theorem D remain valid under the assumption that the $H_{j}$ 's are in general position?
$+)$ What is a generalization of Theorem D for the case $n \geqslant 3$ ?

In connection with the above results, it is also an interesting problem to ask whether these results remain valid if the number of hyperplanes is replaced by a smaller one. In this paper, we will try to get some partial answers to this problem. We give a uniqueness theorem for the case $q \geqslant$ $n+I(\sqrt{2 n(n+1)})+1$ and a theorem of the linear degeneration for the case of $(2 n+2)$ moving targets (where we denote $I(x):=\min \left\{k \in \mathbb{N}_{0}: k>x\right\}$ for a positive constant $x$ ).

Let $f, a$ be two meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$ with reduced representations $f=\left(f_{0}: \ldots: f_{n}\right), a=\left(a_{0}: \ldots: a_{n}\right)$.
Set $(f, a):=a_{0} f_{0}+\ldots+a_{n} f_{n}$. We say that $a$ is "small" with respect to $f$ if $T_{a}(r)=o\left(T_{f}(r)\right)$ as $r \rightarrow \infty$. Assuming that $(f, a) \not \equiv 0$, we denote by $v_{(f, a)}$ the map of $\mathbb{C}^{m}$ into $\mathbb{N}_{0}$ with $v_{(f, a)}(z)=0$ if $(f, a)(z) \neq 0$ and $v_{(f, a)}(z)=k$ if $z$ is a zero point of $(f, a)$ with multiplicity $k$.

Let $a_{1}, \ldots, a_{q} \quad(q \geqslant n+1)$ be meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$ with reduced representations $a_{j}=\left(a_{j 0}: \ldots: a_{j n}\right), j=1, \ldots, q$. We say that $\left\{a_{j}\right\}_{j=1}^{q}$ are in general position if for any $1 \leqslant j_{0}<\ldots<j_{n} \leqslant q$, $\operatorname{det}\left(a_{j_{k}} i, 0 \leqslant k, i \leqslant n\right) \not \equiv 0$.

For each $j \in\{1, \ldots, q\}$, we put $\widetilde{a_{j}}=\left(\frac{a_{j 0}}{a_{j t_{j}}}: \ldots: \frac{a_{j n}}{a_{j t_{j}}}\right)$ and $\left(f, \widetilde{a_{j}}\right)=$ $f_{0} \frac{a_{j 0}}{a_{j t_{j}}}+\ldots+f_{n} \frac{a_{j n}}{a_{j t_{j}}}$ where $a_{j t_{j}}$ is the first element of $a_{j 0}, \ldots, a_{j n}$ not identically equal to zero. Let $\mathcal{M}$ be the field (over $\mathbb{C}$ ) of all meromorphic functions on $\mathbb{C}^{m}$. Denote by $\mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{q}\right) \subset \mathcal{M}$ the subfield generated by the set $\left\{\frac{a_{j i}}{a_{j t_{j}}}, 0 \leqslant i \leqslant n, 1 \leqslant j \leqslant q\right\}$ over $\mathbb{C}$. This subfield is independant of the reduced representations $a_{j}=\left(a_{j 0}: \ldots: a_{j n}\right), j=1, \ldots, q$, and it is of course also independant of our choice of the $a_{j t_{j}}$, because it contains all quotients of the quotients $\frac{a_{j i}}{a_{j t_{j}}}, i=0, \ldots, n$.

We say that $f$ is linearly nondegenerate over $\mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{q}\right)$ if $f_{0}, \ldots, f_{n}$ are linearly independant over $\mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{q}\right)$.

Denote by $\Psi$ the Segre embedding of $\mathbb{C} P^{n} \times \mathbb{C} P^{n}$ into $\mathbb{C} P^{n^{2}+2 n}$ which is defined by sending the ordered pair $\left(\left(w_{0}, \ldots, w_{n}\right),\left(v_{0}, \ldots, v_{n}\right)\right)$ to $\left(\ldots, w_{i} v_{j}, \ldots\right)$ in lexicographic order.

Let $h: \mathbb{C}^{m} \longrightarrow \mathbb{C} P^{n} \times \mathbb{C} P^{n}$ be a meromorphic mapping. Let $\left(h_{0}: \cdots\right.$ : $h_{n^{2}+2 n}$ ) be a representation of $\Psi \circ h$. We say that $h$ is linearly degenerate
(with the algebraic structure in $\mathbb{C} P^{n} \times \mathbb{C} P^{n}$ given by the Segre embedding) if $h_{0}, \ldots, h_{n^{2}+2 n}$ are linearly dependant over $\mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{q}\right)$.

Our main results are stated as follows: Let $n, x, y, p$ be nonnegative integers. Assume that:

\begin{gathered}
2 \leqslant p \leqslant n, 1 \leqslant y \leqslant 2 n, \text { and } \\
0 \leqslant x<\min \left\{2 n-y+1, \frac{(p-1) y}{n+1+y}\right\} .
\end{gathered}
$$

Let $k$ be an integer or $+\infty$ with $\frac{2 n(n+1+y)(3 n+p-x)}{(p-1) y-x(n+1+y)} \leqslant k \leqslant+\infty$.

Theorem 1.1.- Let $f, g$ be two linearly nondegenerate meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$ and $\left\{H_{j}\right\}_{j=1}^{q}$ be $q:=3 n+1-x$ hyperplanes in $\mathbb{C} P^{n}$ in general position.

Set $E_{f}^{j}:=\left\{z \in C^{m}: 0 \leqslant v_{\left(f, H_{j}\right)}(z) \leqslant k\right\},{ }^{*} E_{f}^{j}:=\left\{z \in \mathbb{C}^{m}: 0<\right.$ $\left.v_{\left(f, H_{j}\right)}(z) \leqslant k\right\}$, and similarily for $E_{g}^{j},{ }^{*} E_{g}^{j}, j=1, \ldots, q$.

Assume that :
(a) $\min \left\{v_{\left(f, H_{j}\right)}, 1\right\}=\min \left\{v_{\left(g, H_{j}\right)}, 1\right\}$ on $E_{f}^{j} \cap E_{g}^{j}$
for all $j \in\{n+2+y, \ldots, q\}$, and
$\min \left\{v_{\left(f, H_{j}\right)}, p\right\}=\min \left\{v_{\left(g, H_{j}\right)}, p\right\}$ on $E_{f}^{j} \cap E_{g}^{j}$ for all $j \in\{1, \ldots, n+1+y\}$,
(b) $\operatorname{dim}\left({ }^{*} E_{f}^{i} \cap{ }^{*} E_{f}^{j}\right) \leqslant m-2, \operatorname{dim}\left({ }^{*} E_{g}^{i} \cap{ }^{*} E_{g}^{j}\right) \leqslant m-2$ for all $1 \leqslant i<j \leqslant q$,
(c) $f=g$ on $\bigcup_{j=1}^{q}\left({ }^{*} E_{f}^{j} \cap * E_{g}^{j}\right)$.

Then $f=g$.

We state some corollaries of Theorem 1.1:
$+)$ Take $n \geqslant 2, y=1, p=2, x=0$ and $k \geqslant n(n+2)(6 n+4)$. Then we have:

Corollary 1.2.- Let $f, g$ be two linearly nondegenerate meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}(n \geqslant 2)$ and $\left\{H_{j}\right\}_{j=1}^{3 n+1}$ be hyperplanes in $\mathbb{C} P^{n}$ in general position.

Assume that:
(a) $\min \left\{v_{\left(f, H_{j}\right)}, 1\right\}=\min \left\{v_{\left(g, H_{j}\right)}, 1\right\}$ on $E_{f}^{j} \cap E_{g}^{j}$
for all $j \in\{n+3, \ldots, 3 n+1\}$, and
$\min \left\{v_{\left(f, H_{j}\right)}, 2\right\}=\min \left\{v_{\left(g, H_{j}\right)}, 2\right\}$ on $E_{f}^{j} \cap E_{g}^{j}$ for all $j \in\{1, \ldots, n+2\}$,
(b) $\operatorname{dim}\left({ }^{*} E_{f}^{i} \cap{ }^{*} E_{f}^{j}\right) \leqslant m-2, \operatorname{dim}\left({ }^{*} E_{g}^{i} \cap{ }^{*} E_{g}^{j}\right) \leqslant m-2$
for all $1 \leqslant i<j \leqslant 3 n+1$,
(c) $f=g$ on $\bigcup_{j=1}^{3 n+1}\left({ }^{*} E_{f}^{j} \cap{ }^{*} E_{g}^{j}\right)$.

Then $f=g$.
Corollary 1.2 is an improvement of Theorem C. It is also a kind of generalization of Theorem D to the case where $n \geqslant 2$ and the hyperplanes are in general position.
+) Take $n \geqslant 3, y=n+2, p=3, x=1$ and $k=+\infty$. Then we have:
Corollary 1.3. - Let $f, g$ be two linearly nondegenerate meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}(n \geqslant 3)$ and $\left\{H_{j}\right\}_{j=1}^{3 n}$ be hyperplanes in $\mathbb{C} P^{n}$ in general position.

Assume that:
(a) $\min \left\{v_{\left(f, H_{j}\right)}, 1\right\}=\min \left\{v_{\left(g, H_{j}\right)}, 1\right\}$ for all $j \in\{2 n+4, \ldots, 3 n\}$, and $\min \left\{v_{\left(f, H_{j}\right)}, 3\right\}=\min \left\{v_{\left(g, H_{j}\right)}, 3\right\}$ for all $j \in\{1, \ldots, 2 n+3\}$,
(b) $\operatorname{dim}\left(f^{-1}\left(H_{i}\right) \cap f^{-1}\left(H_{j}\right)\right) \leqslant m-2$ for all $1 \leqslant i<j \leqslant 3 n$,
(c) $f=g$ on $\bigcup_{j=1}^{3 n} f^{-1}\left(H_{j}\right)$.

Then $f=g$.
$+)$ Take $n \geqslant 2, y=I(\sqrt{2 n(n+1)}), p=n, x=2 n-I(\sqrt{2 n(n+1)})$, $k=+\infty$. Then we have:

Corollary 1.4. - Let $f, g$ be two linearly nondegenerate meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}(n \geqslant 2)$ and $\left\{H_{j}\right\}_{j=1}^{n+I}(\sqrt{2 n(n+1)})+1$ be hyperplanes in $\mathbb{C} P^{n}$ in general position.

Assume that:
(a) $\min \left\{v_{\left(f, H_{j}\right)}, n\right\}=\min \left\{v_{\left(g, H_{j}\right)}, n\right\}$
for all $j \in\{1, \ldots, n+I(\sqrt{2 n(n+1)})+1\}$,
(b) $\operatorname{dim}\left(f^{-1}\left(H_{i}\right) \cap f^{-1}\left(H_{j}\right)\right) \leqslant m-2$
for all $1 \leqslant i<j \leqslant n+I(\sqrt{2 n(n+1)})+1$,
(c) $f=g$ on $\bigcup_{j=1}^{n+I(\sqrt{2 n(n+1)})+1} f^{-1}\left(H_{j}\right)$.

Then $f=g$.

We finally give a result for moving targets:

THEOREM 1.5.- Let $f, g: \mathbb{C}^{m} \longrightarrow \mathbb{C} P^{n}(n \geqslant 2)$ be two nonconstant meromorphic mappings with reduced representations $f=\left(f_{0}: \ldots: f_{n}\right)$ and $g=\left(g_{0}: \ldots: g_{n}\right)$.
Let $\left\{a_{j}\right\}_{j=1}^{2 n+2}$ be "small" (with respect to $f$ ) meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$ in general position with reduced representations $a_{j}=\left(a_{j 0}: \ldots: a_{j n}\right), j=1, \ldots, 2 n+2$. Suppose that $\left(f, a_{j}\right) \not \equiv 0,\left(g, a_{j}\right) \not \equiv 0$, $j=1, \ldots, 2 n+2$. Take $M$ an integer or $+\infty$ with

$$
3 n(n+1)\binom{2 n+2}{n+1}^{2}\left[\binom{2 n+2}{n+1}-2\right] \leqslant M \leqslant+\infty
$$

Assume that:
(a) $\min \left\{v_{\left(f, a_{j}\right)}, M\right\}=\min \left\{v_{\left(g, a_{j}\right)}, M\right\}$ for all $j \in\{1, \ldots, 2 n+2\}$,
(b) $\operatorname{dim}\left\{z \in \mathbb{C}^{m}:\left(f, a_{i}\right)(z)=\left(f, a_{j}\right)(z)=0\right\} \leqslant m-2$
for all $i \neq j, i \in\{1, \ldots, n+4\}, j \in\{1, \ldots, 2 n+2\}$,
(c) There exist $\gamma_{j} \in \mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{2 n+2}\right)(j=1, \ldots, 2 n+2)$ such that $\gamma_{j}=\frac{a_{j 0} f_{0}+\ldots+a_{j n} f_{n}}{a_{j 0} g_{0}+\ldots+a_{j n} g_{n}}$ on $\left(\bigcup_{i=1}^{n+4}\left\{z:\left(f, a_{i}\right)(z)=0\right\}\right) \backslash\left\{z:\left(f, a_{j}\right)(z)=0\right\}$.

Then the mapping $f \times g: \mathbb{C}^{m} \longrightarrow \mathbb{C} P^{n} \times \mathbb{C} P^{n}$ is linearly degenerate (with the algebraic structure in $\mathbb{C} P^{n} \times \mathbb{C} P^{n}$ given by the Segre embedding) over $\mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{2 n+2}\right)$.

Remark. - The condiction (c) is weaker than the following easier one:
(c') $f=g$ on $\bigcup_{i=1}^{n+4}\left\{z:\left(f, a_{i}\right)(z)=0\right\}$.
We finally remark that we also obtained uniqueness theorems with moving targets (in [1]), and with fixed targets, but not taking into account, at all, truncations from some fixed order on (in [2]). But in both cases the number of targets has to be bigger than in our results above.

We set $\|z\|=\left(\left|z_{1}\right|^{2}+\ldots+\left|z_{m}\right|^{2}\right)^{1 / 2}$ for $z=\left(z_{1}, \ldots, z_{m}\right) \in \mathbb{C}^{m}$ and define
$B(r):=\left\{z \in \mathbb{C}^{m}:|z|<r\right\}, \quad S(r):=\left\{z \in \mathbb{C}^{m}:|z|=r\right\}$ for all $0<r \leqslant \infty$.
Define $d^{c}:=\frac{\sqrt{-1}}{4 \pi}(\bar{\partial}-\partial), \quad v:=\left(d d^{c}\|z\|^{2}\right)^{m-1}$ and

\sigma:=d^{c} \log \|z\|^{2} \wedge\left(d d^{c} \log \|z\|^{2}\right)^{m-1}
$$

Let $F$ be a nonzero holomorphic function on $\mathbb{C}^{m}$. For every $a \in \mathbb{C}^{m}$, expanding $F$ as $F=\sum P_{i}(z-a)$ with homogeneous polynomials $P_{i}$ of degree $i$ around $a$, we define

$$
v_{F}(a):=\min \left\{i: P_{i} \not \equiv 0\right\} .
$$

Let $\varphi$ be a nonzero meromorphic function on $\mathbb{C}^{m}$. We define the map $v_{\varphi}$ as follows: for each $z \in \mathbb{C}^{m}$, we choose nonzero holomorphic functions $F$ and $G$ on a neighborhood $U$ of $z$ such that $\varphi=\frac{F}{G}$ on $U$ and $\operatorname{dim}\left(F^{-1}(0) \cap G^{-1}(0)\right) \leqslant m-2$, and then we put $v_{\varphi}(z):=v_{F}(z)$.

Set $\left|v_{\varphi}\right|:=\overline{\left\{z \in \mathbb{C}^{m}: v_{\varphi}(z) \neq 0\right\}}$.
Let $k, M$ be positive integers or $+\infty$.

Set

We have the following Jensen's formula (see [5], p.177, observe that his definition of $N_{\varphi}(r)$ is a different one than ours):

For arbitrary fixed homogeneous coordinates $\left(w_{0}: \ldots: w_{n}\right)$ of $\mathbb{C} P^{n}$, we take a reduced representation $f=\left(f_{0}: \ldots: f_{n}\right)$ which means that each $f_{i}$ is a holomorphic function on $\mathbb{C}^{m}$ and $f(z)=\left(f_{0}(z): \ldots: f_{n}(z)\right)$ outside the analytic set $\left\{f_{0}=\ldots=f_{n}=0\right\}$ of codimension $\geqslant 2$. Set $\|f\|=\left(\left|f_{0}\right|^{2}+\ldots+\left|f_{n}\right|^{2}\right)^{1 / 2}$.

The characteristic function of $f$ is defined by

For a meromorphic function $\varphi$ on $\mathbb{C}^{m}$, the proximity function is defined by

and we have, by the classical First Main Theorem that (see [4], p.135)

Here, the characteristic function $T_{\varphi}(r)$ of $\varphi$ is defined as $\varphi$ can be considered as a meroromorphic mapping of $\mathbb{C}^{m}$ into $\mathbb{C} P^{1}$.

We state the First and Second Main Theorem of Value Distribution Theory. Let $a$ be a meromorphic mapping of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$ such that $(f, a) \not \equiv 0$, then for reduced representations $f=\left(f_{0}: \ldots: f_{n}\right)$ and $a=\left(a_{0}: \ldots: a_{n}\right)$, we have:

First Main Theorem. - (Moving target version, see [12], p.569)

For a hyperplane $H: a_{0} w_{0}+\ldots+a_{n} w_{n}=0$ in $\mathbb{C} P^{n}$ with $\operatorname{im} f \nsubseteq H$, we denote $(f, H)=a_{0} f_{0}+\ldots+a_{n} f_{n}$, where $\left(f_{0}: \ldots: f_{n}\right)$ again is a reduced representation of $f$.

Second Main Theorem. - (Classical version) Let $f$ be a linearly nondegenerate meromorphic mapping of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$ and $H_{1}, \ldots, H_{q}$ $(q \geqslant n+1)$ hyperplanes of $\mathbb{C} P^{n}$ in general position, then

(q-n-1) T_{f}(r) \leqslant \sum_{j=1}^{q} N_{\left(f, H_{j}\right)}^{[n]}(r)+o\left(T_{f}(r)\right)
$$

for all $r$ except for a set of finite Lebesgue measure.

## 3. Proof of Theorem 1.1

First of all, we need the following:

Lemma 3.1. - Let $f, g$ be two linearly nondegenerate meromorphic mappings of $\mathbb{C}^{m}$ into $\mathbb{C} P^{n}$ and $\left\{H_{j}\right\}_{j=1}^{q}$ be hyperplanes in $\mathbb{C} P^{n}$ in general position. Then there exists a dense subset $\mathcal{C} \subset \mathbb{C}^{n+1}\{0\}$ such that for any
$c=\left(c_{0}, \ldots, c_{n}\right) \in \mathcal{C}$, the hyperplane $H_{c}$ defined by $c_{0} \omega_{0}+\ldots+c_{0} \omega_{n}=0$ satifies:

Let $j_{0}$ be an arbitrarily fixed index, $j_{0} \in\{1, \ldots, n+1+y\}$. Then there exists a hyperplane $H$ in $\mathbb{C} P^{n}$ such that:

Indeed, suppose that this assertion does not hold. Then by Lemma 3.1 we have $\frac{\left(f, H_{j_{0}}\right)}{(f, H)} \equiv \frac{\left(g, H_{j_{0}}\right)}{(g, H)}$ for all hyperplanes $H$ in $\mathbb{C} P^{n}$. In particular, $\frac{\left(f, H_{j_{0}}\right)}{\left(f, H_{j_{i}}\right)} \equiv \frac{\left(g, H_{j_{0}}\right)}{\left(g, H_{j_{i}}\right)}, i \in\{1, \ldots, n\}$ where $\left\{j_{1}, \ldots, j_{n}\right\}$ is an arbitrary subset of $\{1, \ldots, q\} \backslash\left\{j_{0}\right\}$. After changing the homogeneous coordinates $\left(w_{0}: \ldots: w_{n}\right)$ on $\mathbb{C} P^{n}$ we may assume that $H_{j_{i}}: w_{i}=0,(i=0, \ldots, n)$. Then $\frac{f_{0}}{f_{i}}=\frac{g_{0}}{g_{i}}$ for all $i \in\{1, \ldots, n\}$. This means that $f \equiv g$. This is a contradiction. Thus we get (3.1).

Since $\min \left\{v_{\left(f, H_{j_{0}}\right)}, p\right\}=\min \left\{v_{\left(g, H_{j_{0}}\right)}, p\right\}$ on $E_{f}^{j_{0}} \cap E_{g}^{j_{0}}, f=g$ on $\bigcup_{j=1}^{q}\left({ }^{*} E_{f}^{j} \cap{ }^{*} E_{g}^{j}\right)$ and by (3.1) we have that a zero point $z_{0}$ of $\left(f, H_{j_{0}}\right)$ with multiplicity $\leqslant k$ is either a zero point of $\frac{\left(f, H_{j_{0}}\right)}{(f, H)}-\frac{\left(g, H_{j_{0}}\right)}{(g, H)}$ with multiplicity $\geqslant \min \left\{v_{\left(f, H_{j_{0}}\right)}\left(z_{0}\right), p\right\}$ or a zero point of $\left(g, H_{j_{0}}\right)$ with multiplicity $>k$ (outside an analytic set of codimension $\geqslant 2$ ).

For any $j \in\{1, \ldots, q\}\left\{j_{0}\right\}$, by the asumptions (a),(c) and by (3.1), we have that a zero point of $\left(f, H_{j}\right)$ with multiplicity $\leqslant k$ is either a zero point of $\frac{\left(f, H_{j_{0}}\right)}{(f, H)}-\frac{\left(g, H_{j_{0}}\right)}{(g, H)}$ or zero point of $\left(g, H_{j}\right)$ with multiplicity $>k$ (outside an analytic set of codimension $\geqslant 2$ ).

By (3.2) and (3.3), the assumption (b) and by the First Main Theorem we have

## 4. Proof of Theorem 1.5

Let $\mathcal{G}$ be a torsion free abelian group and $A=\left(x_{1}, \ldots, x_{q}\right)$ be a $q$-tuple of elements $x_{i}$ in $\mathcal{G}$. Let $1<s<r \leqslant q$. We say that $A$ has the property $P_{r, s}$ if any $r$ elements $x_{p_{1}}, \ldots, x_{p_{r}}$ in $A$ satisfy the condition that for any subset $I \subset\left\{p_{1}, \ldots, p_{r}\right\}$ with $\# I=s$, there exists a subset $J \subset\left\{p_{1}, \ldots, p_{r}\right\}$, $J \neq I, \# J=s$ such that $\prod_{i \in I} x_{i}=\prod_{j \in J} x_{j}$.

Lemma 4.1. - If $A$ has the property $P_{r, s}$, then there exists a subset $\left\{i_{1}, \ldots, i_{q-r+2}\right\} \subset\{1, \ldots, q\}$ such that $x_{i_{1}}=\ldots=x_{i_{q-r+2}}$.

Proof. - We refer to [3], Lemma 2.6.

LEMMA 4.2.- Let $f: C^{m} \longrightarrow C P^{n}$ be a nonconstant meromorphic mapping and $\left\{a_{i}\right\}_{i=0}^{n}$ be "small" (with respect to $f$ ) meromorphic mappings of $C^{m}$ into $C P^{n}$ in general position.

Denote the meromorphic mapping,

It is easy to see that: $V_{12} \cup V_{23} \cup V_{13}=\{1, \ldots, n+4\}$.
Thus,
$N_{\frac{h_{I_{1}}}{h_{I_{2}}}-\frac{\gamma_{I_{1}}}{\gamma_{I_{2}}}}(r)+N_{\frac{h_{I_{2}}}{h_{I_{3}}}-\frac{\gamma_{I_{2}}}{\gamma_{I_{3}}}}(r)+N_{\frac{h_{I_{3}}}{h_{I_{1}}}-\frac{\gamma_{I_{3}}}{\gamma_{I_{1}}}}(r) \geqslant \sum_{i=1}^{n+4} N_{\left(f, a_{i}\right)}^{[1]}(r) \geqslant \sum_{i=1}^{n+2} N_{\left(f, a_{i}\right)}^{[1]}(r)$

By (4.15) and (4.16) we have

$$
\begin{equation*}
\sum_{i=1}^{n+2} N_{\left(f, a_{i}\right)}^{[1]}(r) \leqslant \frac{3(n+1) t^{2}(t-2)}{(M+1) n} T_{f}(r)+o\left(T_{f}(r)\right), r \in E \tag{4.17}
\end{equation*}
$$

We now prove that:

$$
\begin{equation*}
\frac{1}{n} T_{f}(r) \leqslant \sum_{i=1}^{n+2} N_{\left(f, a_{i}\right)}^{[1]}(r)+o\left(T_{f}(r)\right) \tag{4.18}
\end{equation*}
$$

Set

$$
N_{n+2}:=\left(\begin{array}{ccc}
\frac{a_{10}}{a_{1 t_{1}}} & \cdots & \frac{a_{(n+1) 0}}{a_{(n+1) t_{n+1}}} \\
\vdots & \ddots & \vdots \\
\frac{a_{1 n}}{a_{1 t_{1}}} & \cdots & \frac{a_{(n+1) n}}{a_{(n+1) t_{n+1}}}
\end{array}\right),
$$

and matrices $N_{i}(i \in\{1, \ldots, n+1\})$ which are defined by $N_{n+2}$ after changing the $i^{\text {th }}$ column by $\left(\begin{array}{c}\frac{a_{(n+2) 0}}{a_{(n+2) t_{n+2}}} \\ \vdots \\ \frac{a_{(n+2) n}}{a_{(n+2) t_{n+2}}}\end{array}\right)$.

Put $c_{i}=\operatorname{det}\left(N_{i}\right),(i=1, \ldots, n+2)$, then $\left\{c_{i}\right\}_{i=1}^{n+2}$ are nonzero meromorphic functions on $\mathbb{C}^{m}$ and $c_{i} \in \mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{2 n+2}\right)$.

It is easy to see that:

$$
\begin{equation*}
\sum_{i=1}^{n+1} c_{i}\left(f, \widetilde{a_{i}}\right)=c_{n+2}\left(f, \widetilde{a_{n+2}}\right) \tag{4.19}
\end{equation*}
$$

Denote by $F$ the meromorphic mapping $\left(c_{1}\left(f, \widetilde{a_{1}}\right): \ldots: c_{n+1}\left(f, \widetilde{a_{n+1}}\right)\right)$ : $\mathbb{C}^{m} \rightarrow \mathbb{C} P^{n}$.

Since $f$ is linearly nondegenerate over $\mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{2 n+2}\right)$ and since $\left\{a_{j}\right\}_{j=1}^{2 n+2}$ are in general position, we have that $F$ is linearly nondegenerate (over $\mathbb{C}$ ).

By Lemma 4.2 we have

$$
T_{F}(r)=T_{f}(r)+o\left(T_{f}(r)\right) .
$$

Let $\left(\frac{c_{1}\left(f, \widetilde{a_{1}}\right)}{h}: \ldots: \frac{c_{n+1}\left(f, \widetilde{a_{n+1}}\right)}{h}\right)$ be a reduced representation of F , where $h$ is a meromorphic function on $\mathbb{C}^{m}$. By Lemma 4.2 we have

$$
N_{h}(r)=o\left(T_{f}(r)\right), N_{\frac{1}{h}}(r)=o\left(T_{f}(r)\right) .
$$

By the Second Main Theorem, we have:

$$
\begin{aligned}
T_{f}(r)+o\left(T_{f}(r)\right)= & T_{F}(r) \leqslant \sum_{i=1}^{n+1} N_{\frac{c_{i}\left(f, \widetilde{a}_{i}\right)}{h}}^{[n]}(r)+N_{n+1}^{[n]} \frac{\sum_{i=1}^{\left[\frac{c_{i}\left(f, \widetilde{a}_{i}\right)}{h}\right.}}{}(r)+o\left(T_{F}(r)\right) \\
& \stackrel{(4.19)}{=} \sum_{i=1}^{n+2} N_{c_{i}\left(f, \widetilde{a}_{i}\right)}^{[n]}(r)+N_{\frac{1}{h}}(r)+o\left(T_{F}(r)\right) \\
\leqslant & \sum_{i=1}^{n+2} N_{\left(f, a_{i}\right)}^{[n]}(r)+\sum_{i=1}^{n+2} N_{\frac{1}{a_{i t_{i}}}}(r)+\sum_{i=1}^{n+2} N_{c_{i}}(r)+o\left(T_{F}(r)\right) \\
\leqslant & n \sum_{i=1}^{n+2} N_{\left(f, a_{i}\right)}^{[1]}(r)+o\left(T_{f}(r)\right) .
\end{aligned}
$$

We get (4.18).
By (4.17) and (4.18) we have :

$$
T_{f}(r) \leqslant \frac{3(n+1) t^{2}(t-2)}{(M+1)} T_{f}(r)+o\left(T_{f}(r)\right), r \in E .
$$

This contradicts to

$$
M \geqslant 3 n(n+1)\binom{2 n+2}{n+1}^{2}\left[\binom{2 n+2}{n+1}-2\right] \geqslant 3(n+1) t^{2}(t-2)
$$

Case 2.- $B_{v} \equiv 0$ for all $v \in\{1, \ldots, s\}$. Then $\sum_{I \in L_{v}} A_{I} h_{I} \equiv 0$ for all $v \in\{1, \ldots, s\}$. On the other hand $A_{I} \not \equiv 0, h_{I} \not \equiv 0$. Hence, $\# L_{v} \geqslant 2$ for all $v \in\{1, \ldots, s\}$.

So, for each $I \in L$, there exists $J \in L, J \neq I$ such that $\frac{h_{I}}{h_{J}} \in \mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{2 n+2}\right)$. This implies that $\prod_{i \in I}\left[h_{i}\right]=\prod_{i \in J}\left[h_{j}\right]$.

We get (4.5).

By Lemma 4.1 there exist $j_{1}, j_{2} \in\{1, \ldots, 2 n+2\}, j_{1} \neq j_{2}$ such that $\left[h_{j_{1}}\right]=\left[h_{j_{2}}\right]$.

By the definition, we have $\frac{h_{j_{1}}}{h_{j_{2}}} \in \mathcal{H}$. This means that $\left(\frac{h_{j_{1}}}{h_{j_{2}}}\right)^{k} \in \mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{2 n+2}\right)$ for some positive integer $k$.

So $\left(\frac{\left(f, a_{j_{1}}\right)\left(g, a_{j_{2}}\right)}{\left(g, a_{j_{1}}\right)\left(f, a_{j_{2}}\right)}\right)^{k} \in \mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{2 n+2}\right)$.
Take $\left\{i_{1}, \ldots, i_{n+2}\right\} \subseteq\{1, \ldots, n+4\} \backslash\left\{j_{1}, j_{2}\right\}$.
Similarly to (4.18), we have:

$$
\begin{equation*}
\frac{1}{n} T_{f}(r) \leqslant \sum_{s=1}^{n+2} N_{\left(f, a_{i_{s}}\right)}^{[1]}(r)+o\left(T_{f}(r)\right) . \tag{4.20}
\end{equation*}
$$

$+)$ If $\left(\frac{\left(f, a_{j_{1}}\right)\left(g, a_{j_{2}}\right)}{\left(g, a_{j_{1}}\right)\left(f, a_{j_{2}}\right)}\right)^{k}-\left(\frac{\gamma_{j_{1}}}{\gamma_{j_{2}}}\right)^{k} \not \equiv 0$, then by the assumptions (b) and (c) we have

Indeed, let $z_{0}$ be an arbitrary zero point of some $\left(f, a_{i_{s}}\right),(1 \leqslant s \leqslant$ $n+2)$. By omitting an analytic set of codimemsion $\geqslant 2$, we may assume that $\left(f, a_{j_{1}}\right)\left(z_{0}\right) \neq 0,\left(f, a_{j_{2}}\right)\left(z_{0}\right) \neq 0$ (note that $\left.j_{1}, j_{2} \neq i_{s}\right)$. Then $\gamma_{j_{1}}\left(z_{0}\right)=\frac{\left(f, a_{j_{1}}\right)}{\left(g, a_{j_{1}}\right)}\left(z_{0}\right), \quad \gamma_{j_{2}}\left(z_{0}\right)=\frac{\left(f, a_{j_{2}}\right)}{\left(g, a_{j_{2}}\right)}\left(z_{0}\right)$. Thus $z_{0}$ is a zero point of $\left(\frac{\left(f, a_{j_{1}}\right)\left(g, a_{j_{2}}\right)}{\left(g, a_{j_{1}}\right)\left(f, a_{j_{2}}\right)}\right)^{k}-\left(\frac{\gamma_{j_{1}}}{\gamma_{j_{2}}}\right)^{k}$. We get (4.21).

By the First Main Theorem and by (4.20), (4.21) we have:

$$
T_{\left(\frac{\left(f, a_{j_{1}}\right)\left(g, a_{j_{2}}\right)}{\left(g, a_{j_{1}}\right)\left(f, a_{j_{2}}\right)}\right)^{k}}(r)+T_{\left(\frac{\gamma_{j_{1}}}{\gamma_{j_{2}}}\right)^{k}(r) \geqslant N}^{\left(\frac{\left(f, a_{j_{1}}\right)\left(g, a_{j_{2}}\right)}{\left(g, a_{j_{1}}\right)\left(f, a_{j_{2}}\right)}\right)^{k}-\left(\frac{\gamma_{j_{1}}}{\gamma_{j_{2}}}\right)^{k}(r)}
$$

$$
\geqslant \sum_{s=1}^{n+2} N_{\left(f, a_{i_{s}}\right)}^{[1]}(r) \geqslant \frac{1}{n} T_{f}(r)+o\left(T_{f}(r)\right) .
$$

This is a contradiction, since $\gamma_{j_{1}}, \gamma_{j_{2}},\left(\frac{\left(f, a_{j_{1}}\right)\left(g, a_{j_{2}}\right)}{\left(g, a_{j_{1}}\right)\left(f, a_{j_{2}}\right)}\right)^{k} \in \mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{2 n+2}\right)$.
Thus, $\left(\frac{\left(f, a_{j_{1}}\right)\left(g, a_{j_{2}}\right)}{\left(g, a_{j_{1}}\right)\left(f, a_{j_{2}}\right)}\right)^{k} \equiv\left(\frac{\gamma_{j_{1}}}{\gamma_{j_{2}}}\right)^{k}$. So, $\frac{\left(f, a_{j_{1}}\right)\left(g, a_{j_{2}}\right)}{\left(g, a_{j_{1}}\right)\left(f, a_{j_{2}}\right)} \equiv \alpha \frac{\gamma_{j_{1}}}{\gamma_{j_{2}}}$, where $\alpha$ is a constant. This implies that $f \times g$ is linearly degenerate over $\mathcal{R}\left(\left\{a_{j}\right\}_{j=1}^{2 n+2}\right)$.

We have completed proof of Theorem 1.5.
