# GALOIS MODULE STRUCTURE OF IDEALS IN WILDLY RAMIFIED CYCLIC EXTENSIONS OF DEGREE $p^{2}$

## 1. Introduction.

Let $L / K$ be a totally ramified cyclic extension of degree $p^{2}$ of local fields which are finite extensions of $\mathbb{Q}_{p}$, the field of $p$-adic numbers. Let $\mathfrak{O}_{L}$ be the ring of integers in $L$, and let $\mathfrak{P}_{L}$ be its unique maximal ideal. Then each fractional ideal, $\mathfrak{P}_{L}^{n}$ where $n$ is a rational integer, is canonically a $\mathbb{Z}_{p}[G]$-module, where $G=\operatorname{Gal}(L / K)$ and $\mathbb{Z}_{p}$ is the ring of $p$-adic integers. By the Krull-Schmidt Theorem, $\mathfrak{P}_{L}^{n}$ decomposes uniquely into a direct sum of indecomposable $\mathbb{Z}_{p}[G]$ - modules. What is this decomposition? In this paper, we give the $\mathbb{Z}_{p}[G]$-module decomposition of $\mathfrak{P}_{L}^{n}$ explicitly in terms of the following : the $4 p+1$ indecomposable $\mathbb{Z}_{p}[G]$-modules classified by Heller and Reiner [5] Thm 34.32, the lower ramification numbers of $L / K$, the absolute ramification index of $K / \mathbb{Q}_{p}$, and $n$ itself. It should be noted that a partial answer for $\mathfrak{O}_{L}$, the particular case $n \equiv 0 \bmod p^{2}$, was given by Rzedowski-Calderón, Villa- Salvador and Madan [16] Thm 2, under a rather severe restriction on the first ramification number. In this paper, we eliminate the need for the restriction required by [16], and generalize the result to include all fractional ideals.

In the second section we introduce the notation recalling, in particular, the $4 p+1$ indecomposable $\mathbb{Z}_{p}[G]$ - modules. Then in the third section, we state and prove our main result. The proof consists of four steps, the

[^0]most important of which is the choice of a suitable explicit integral basis for $\mathfrak{P}_{L}^{n H}$ which is amenable to an analysis of the Galois action, where $\mathfrak{P}_{L}^{n H}$ denotes the submodule of $\mathfrak{P}_{L}^{n}$ fixed under the subgroup, $H$, of index $p$. In the final section, we end with some remarks.

The reader is referred to [16] for more background, to joint work with Madan [6] for a generalization of [16] to arbitrarily large cyclic extensions of $p$-power degree and to the papers of Miyata [15] and Vostokov [19] for a discussion of the $\mathfrak{O}_{K}[G]$-module structure of $\mathfrak{P}_{L}^{n}$. Note that in the papers of Miyata and Vostokov, the focus is on conditions under which $\mathfrak{P}_{L}^{n}$ is indecomposable as an $\mathfrak{O}_{K}[G]$-module; (it almost always is!). As we will see, $\mathfrak{P}_{L}^{n}$ is almost always decomposable as a $\mathbb{Z}_{p}[G]$-module.

It should also be mentioned that, motivated by the work of Leopoldt [10], J. Martinet [12] has introduced the concept of the associated order, $\mathcal{A}=\left\{x \in K[G]: x \mathfrak{O}_{L} \subseteq \mathfrak{O}_{L}\right\}$. What, then, is the structure of $\mathfrak{O}_{L}$ as an $\mathcal{A}$ module? This problem has been extensively studied, notably by Bergé [1], F. Bertrandias [2], J.-P. Bertrandias [3] and M.-J. Ferton [7].

Finally, the standard reference for the Galois module structure of the ring of integers in global number fields is Fröhlich's book [8].

## 2. Notation.

Let $p$ be a rational prime and let $K_{2} / K_{0}$ be a cyclic, totally ramified extension of local fields of degree $p^{2}$, with $\left[K_{0}: \mathbb{Q}_{p}\right]=e_{0} f, e_{0}$ denoting the absolute ramification index. Let $G=\operatorname{Gal}\left(K_{2} / K_{0}\right)$ be generated by $\sigma$. Let $K_{1}$ be the fixed field of $H=\left\langle\sigma^{p}\right\rangle$. Let $\mathfrak{D}_{i}$ be the ring of integers of $K_{i}, \mathfrak{P}_{i}$ be the unique maximal ideal of $\mathfrak{O}_{i}$, and from now on, let $\mathfrak{P}_{2}^{n}$ be a particular fractional ideal. So $n$ is a fixed rational integer. Let $\pi_{i}$ be a prime element of $K_{i}, v_{i}$ be the normalized valuation of $K_{i}$ so that $v_{i}\left(\pi_{i}\right)=1$, and let $\mathbb{F}_{p}$ be the field of $p$ elements. Let $T$ be the largest unramified extension of $\mathbb{Q}_{p}$ contained in $K_{0}$, so $\left[T: \mathbb{Q}_{p}\right]=f$, and let $\mathfrak{D}_{T}$ be its ring of integers.

Let $b_{1}, b_{2}$ be the lower ramification numbers of $K_{2} / K_{0}$, and for any rational integer, $x$, let $\mathfrak{P}_{k}^{\lambda_{j, k}(x)}$ be the largest power of $\mathfrak{P}_{k}$ to divide $\mathfrak{P}_{j}^{x} \mathfrak{D}_{K_{j} / K_{k}}$, where $\mathfrak{D}_{K_{j} / K_{k}}$ denotes the relative different. Let $\lfloor x\rfloor$ denote the floor function (i.e. the greatest integer function), and $\lceil x\rceil$, the ceiling function (i.e. the least integer function), where these two functions are
related by $\left\lfloor\frac{x-1}{p}\right\rfloor=\left\lceil\frac{x}{p}\right\rceil-1$. It is easily seen using [18] pg 64, that
(1) $\lambda_{1,0}(x)=\left\lfloor\frac{x+\left(b_{1}+1\right)(p-1)}{p}\right\rfloor, \lambda_{2,1}(x)=\left\lfloor\frac{x+\left(b_{2}+1\right)(p-1)}{p}\right\rfloor$,

In fact if $T_{K_{j} / K_{k}}$ denotes the relative trace from $K_{j}$ to $K_{k}$, then as in a theorem of Yokoi [21] Thm 1,

At this point we should also note that the submodule of $\mathfrak{P}_{2}^{n}$ fixed under $H$ is $\mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$, while the submodule fixed under $G$ is $\mathfrak{P}_{0}^{\left\lceil\frac{n}{p^{2}}\right\rceil}$.

We recall the following notation for the $4 p+1$ indecomposable $\mathbb{Z}_{p}[G]$ modules [5] Thm 34.32 :

And for each of these modules we give explicit interpretations, following [16] $\mathrm{pg} 407-8$ and [5] pg 175-6. In each case, $\sigma$ acts via multiplication by $x$, and $\Phi_{p^{i}}(x)$ denotes the $p^{i}$-th cyclotomic polynomial.

Note that $\left(R_{2}, E ; \lambda^{0}\right) \cong \mathbb{Z}_{p}[G]$. In Theorem 1 , we determine which of these indecomposables appears in the $\mathbb{Z}_{p}[G]$ - decomposition of $\mathfrak{P}_{2}^{n}$. Notice that the precise decomposition depends only on $e_{0}, f, b_{1}, b_{2}$ and $n$.

## 3. The main result.

Theorem 1. - Using the notation introduced above :

Remark. - Byott has studied $\mathfrak{O}_{k}[G]$-isomorphisms among fractional ideals in [4]. Note that one can use this theorem to determine the existence of $\mathbb{Z}_{p}[G]$ - isomorphisms between any two given fractional ideals in totally ramified cyclic extensions of degree $p^{2}$. Remark : There are certain conditions under which the statement of the theorem becomes more manageable. Of course there are other conditions under which the statement is quite unmanageable. In what follows we discuss three different situations : 1) If $\lambda_{2,0}(n) \leq e_{0}+\left[\frac{n}{p^{2}}\right]$ then the expression in Theorem 1 becomes quite simple : $r=s=0, b=0$ and $h_{i}=0$ for all $i$. Note that this condition occurs when the ramification numbers are relatively small, which is quite unexpected. Generally it is not when the ramification numbers are small but when they are large that things are well behaved, see Wyman's discussion of stable ramification [20], and also [6]. 2) If $b_{1}$ is too small with respect to $p$, the expression becomes somewhat sporadic. For instance, when $b_{1}=1$, $n \equiv 1 \bmod p^{2}$ and $p \geq 3$, then $b_{2}=1+p(u p-v)$ for some integer $u$, and $v \in\{0,1, \ldots p-1\}, a=b=0, c=u(p-1)-v, d_{i}=0$ for all $i$, $g_{0}=e_{0}-u(p-1)+v$ for $v=0, g_{0}=e_{0}-u(p-1)+v-1$ for $v \neq 0$, $g_{i}=0$ for $i \neq v \neq 0, g_{v}=1$ for $v \neq 0, h_{i}=0$ for all $i$ and $k=u(p-1)-v$. Notice that in this case, $f$ copies of $\left(R_{2}, E ; \lambda^{i}\right)$ appear for different values of $i$ depending on $v .3$ ) If, on the other hand, $b_{1}$ is large enough with respect to $p$, the expression behaves smoothly as we vary $b_{2}$. The invariants, $r, s$, $s_{i}$, do not take on wildly different values. In fact it is easily seen that if we choose $b_{1}$ large enough, $r, s$ and $s_{i}$ all take on roughly the same value. One can also see that in this case, all the $g_{i}$ for $i>s$ and all the $d_{i}$ for $i>r$ have approximately the same value, $\left\lfloor b_{1} / p\right\rfloor \approx\left\lceil b_{1} / p\right\rceil$.

Proof of Theorem 1. - The theorem is proven in four steps. But first, we observe that there is one particular pair of ramification numbers which warrants special consideration. This pair occurs when $p$ divides the first ramification number, $b_{1}$. It is well-known, [20], that $p \mid b_{1}$ implies $K_{0}$ contains the $p$-th roots of unity, $b_{1}=\frac{p e_{0}}{p-1}$ and $b_{2}=\frac{p^{2} e_{0}}{p-1}$. In this case, the reader may check that the following members of $\mathbb{Q}_{p}[G]$ map $\mathfrak{P}_{2}^{n}$ into itself : $\frac{1}{p^{2}} T_{K_{2} / K_{0}}, \frac{1}{p} T_{K_{2} / K_{1}}-\frac{1}{p^{2}} T_{K_{2} / K_{0}}$ and $1-\frac{1}{p} T_{K_{2} / K_{1}}$. Therefore,

From now on, we shall exclude this special case from our consideration, and assume that $b_{1}$ and, hence, $b_{2}$ is relatively prime to $p$.

Step 1. In this step we construct a special basis for $\mathfrak{P}^{\left\lceil\frac{n}{p}\right\rceil}$ over $\mathfrak{O}_{T}$ which is amenable to the investigation of its Galois module structure. Our first lemma is well known, we state and prove it for the sake of completeness.

Lemma 1. - $v_{1}\left((\sigma-1)^{i} \pi_{1}^{b_{1}}\right)=(i+1) b_{1}$ for $i=0,1,2, \ldots, p-1$, and $v_{1}\left((\sigma-1)^{p-1} \pi_{1}^{b_{1}}\right)=v_{1}\left(\left(1+\sigma+\sigma^{2}+\cdots+\sigma^{p-1}\right) \pi_{1}^{b_{1}}\right)=p b_{1}$.

Note. - In a paper of MacKenzie and Whaples [11], it was shown that cyclic extensions of degree $p$ with $\left(b_{1}, p\right)=1$ are generated by a root, $\Lambda$, of an Artin-Schreier equation, $x^{p}-x-\lambda=0$, with $v_{0}(\lambda)=-b_{1}$. Clearly, $v_{1}(\Lambda)=-b_{1}$. Therefore, $\Lambda^{-1}$ can be used as a canonical replacement for the element $\pi_{1}^{b_{1}}$ in the statement of this lemma.

Proof. - Let $y_{0}=1, y_{1}=\pi_{1}, y_{2}=\pi_{1} \sigma\left(\pi_{1}\right), \ldots, y_{n}=\pi_{1} \sigma\left(\pi_{1}\right) \ldots$ $\sigma^{n-1}\left(\pi_{1}\right)$, as in Sen [17]. Clearly, $v_{1}\left(y_{i}\right)=i$, and $p \mid i$ implies $y_{i} \in K_{0}$. The $\left\{y_{i}\right\}_{i=0}^{p e_{0}-1}$ form a basis for $\mathfrak{O}_{1}$ over $\mathfrak{O}_{T}$. Now,

Of course $v_{1}\left(\pi_{1}^{b_{1}}\right)=b_{1}$ and $p \nmid b_{1}$. Assume now that for $1 \leq i \leq p-1$, $v_{1}\left((\sigma-1)^{i-1} \pi_{1}^{b_{1}}\right)=i b_{1}$, then clearly $p \nmid i b_{1}$, and $(\sigma-1)^{i-1} \pi_{1}^{b_{1}}=$ $u y_{i b_{1}}+w$, for some unit, $u$, of $\mathfrak{D}_{0}$, and some element, $w$, of $\mathfrak{D}_{1}$ with strictly higher valuation than $i b_{1}$. Using (6), $v_{1}\left((\sigma-1)^{i} \pi_{1}^{b_{1}}\right)=v_{1}\left((\sigma-1) y_{i b_{1}}\right)=$ $(i+1) b_{1}$. By (1) and (2), $v_{0}\left(T_{K_{1} / K_{0}}\left(\pi_{1}^{b_{1}}\right)\right)=\left\lfloor\frac{b_{1}+\left(b_{1}+1\right)(p-1)}{p}\right\rfloor=b_{1}$, and so $v_{1}\left(\Phi_{p}(\sigma) \pi_{1}^{b_{1}}\right)=p b_{1}$.

Lemma $2\left(\right.$ A special $\mathfrak{O}_{T^{-}}$-basis for $\left.\mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}\right)$. Let $t_{m}=\left\lceil\frac{n-p^{2} m}{p b_{1}}\right\rceil-2$, then

Proof. - As a first step, define the following sets :
$A_{m}=\left\{v_{1}\left((\sigma-1)^{i} \pi_{1}^{b_{1}} \pi_{0}^{m}\right\}_{i=0}^{p-1}\right.$ for all $m \in \mathbb{Z}$, where $\mathbb{Z}$ is the integers. It is an easy exercise to check that the sets $A_{m}$ are mutually disjoint, and that $\bigcup_{m \in \mathbb{Z}} A_{m}=\mathbb{Z}$. By choosing elements, $(\sigma-1)^{i} \pi_{1}^{b_{1}} \pi_{0}^{m}$ with $\left\lceil\frac{n}{p}\right\rceil \leq$ $(i+1) b_{1}+p m \leq p e_{0}+\left\lceil\frac{n}{p}\right\rceil-1$, we arrive at a basis for $\mathfrak{O}_{1}$ over $\mathfrak{O}_{T}$. For $\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1} \leq m \leq\left\lceil\frac{n-p b_{1}}{p^{2}}\right\rceil-1$, we then may replace $(\sigma-1)^{p-1} \pi_{1}^{b_{1}} \pi_{0}^{m}$ by $\Phi_{p}(\sigma) \pi_{1}^{b_{1}} \pi_{0}^{m}$, using Lemma 1 . Then clearly each $(\sigma-1)^{i} \pi_{1}^{b_{1}} \pi_{0}^{m}$ where $e_{0}+\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1} \leq m \leq e_{0}+\left\lceil\frac{n-p b_{1}}{p^{2}}\right\rceil-1$ and $(i+1) b_{1}+p m \leq p e_{0}-1$ can be replaced by $(\sigma-1)^{i} p \pi_{1}^{b_{1}} \pi_{0}^{m}$ where $\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1} \leq m \leq\left\lceil\frac{n-p b_{1}}{p^{2}}\right\rceil-1$. The condition, $(i+1) b_{1}+p\left(e_{0}+m\right) \leq p e_{0}+\left\lceil\frac{n}{p}\right\rceil-1$, is then equivalent to $i \leq\left\lceil\frac{n-p^{2} m}{p b_{1}}\right\rceil-2$.

We now know that the first two summands in the statement of Lemma 2 correspond to $Z$ 's and $E$ 's. As one might expect, knowing [16] Thm 1, the final summand should somehow correspond to a collection of $R_{1}$ 's.

Proof. - Clearly, these are $\mathbb{Z}_{p}$-torsion free modules which are annihilated by $\Phi_{p}(\sigma)$. What remains to be shown is that they are closed under the group action : given a basis element $\alpha$, that $(\sigma-1) \alpha$ is expressible as a linear combination of basis elements. Clearly, the only difficulty lies in showing this for $\alpha=(\sigma-1)^{p-2} \pi_{1}^{b_{1}} \pi_{0}^{m}$. But by a lemma of Hasse [9] pg. $76, \Phi_{p}(\sigma)=\sum_{i=0}^{p-1}\binom{p}{i+1}(\sigma-1)^{i}$. So, $(\sigma-1) \alpha=(\sigma-1)^{p-1} \pi_{1}^{b_{1}} \pi_{0}^{m}=$

Corollary 1. - For any integer, $x$, let $r(x)=x-p\left\lfloor\frac{x-1}{p}\right\rfloor$ be the remainder in $\{1,2, \ldots, p\}$ of $x$ divided by $p$. Let $\varphi\left(\mathfrak{P}_{1}^{x}\right)=$ $\left\lfloor\frac{r(x)-r\left(b_{1}+1\right)}{p}\right\rfloor+1$, then
$\mathfrak{P}_{1}^{s} \cong \mathfrak{P}_{1}^{t}$ as $\mathbb{Z}_{p}[G]$ - modules, if and only if $\varphi\left(\mathfrak{P}_{1}^{s}\right)=\varphi\left(\mathfrak{P}_{1}^{t}\right)$.
Note that $\varphi\left(\mathfrak{P}_{1}^{x}\right)$ takes values in $\{0,1\}$, that $\varphi\left(\mathfrak{D}_{K_{1} / K_{0}}^{-1}\right)=\varphi\left(\mathfrak{D}_{1}\right)=1$, in fact that $\varphi\left(\mathfrak{P}_{1}^{t}\right)=1$ for all $t$ if $p \mid b_{1}$, but that if $\left(p, b_{1}\right)=1$ then $\varphi\left(\mathfrak{P}_{1}\right)=\cdots=\varphi\left(\mathfrak{P}_{1}^{r\left(b_{1}+1\right)-1}\right)=0$.

Proof. - Clearly $\mathfrak{P}_{1}^{s} \cong \mathfrak{P}_{1}^{t}$ as $\mathbb{Z}_{p}[G]$-modules if and only if $\lambda_{1,0}(s)-$ $\left\lceil\frac{s}{p}\right\rceil=\lambda_{1,0}(t)-\left\lceil\frac{t}{p}\right\rceil$ which is equivalent to $\left\lfloor\frac{s+\left(b_{1}+1\right)(p-1)}{p}\right\rfloor-\left\lceil\frac{s}{p}\right\rceil=$
$\left\lfloor\frac{t+\left(b_{1}+1\right)(p-1)}{p}\right\rfloor-\left\lceil\frac{t}{p}\right\rceil$. This, it is easily seen, is equivalent to $\left\lfloor\frac{r(s)-r\left(b_{1}+1\right)}{p}\right\rfloor=\left\lfloor\frac{r(t)-r\left(b_{1}+1\right)}{p}\right\rfloor$.

Step 2. In this step we provide elements of $\mathfrak{P}_{1}^{\lambda_{2,1}(n)}$ which generate $\mathfrak{P}_{1}^{\lambda_{2,1}(n)} / p \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}$ over $\mathfrak{O}_{T} / p \mathfrak{O}_{T}[G]$. First, we list the valuations of a basis for $\mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$ over $\mathfrak{O}_{T}$. For $m=\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1}, \ldots,\left\lceil\frac{n-p b_{1}}{p^{2}}\right\rceil-1$,

Next, we graph this basis in Figure I, plotting the valuation of each member of the basis against the parameter $m$. This diagram will prove insightful, turning some of the arguments that follow into easy exercises. Note that each horizontal row, determined by a fixed value of $m$, represents an $\mathfrak{O}_{T}[G]$ - module, which is either a copy of $\mathfrak{O}_{T} \otimes_{\mathbb{Z}_{p}[G]} E$ (for each row above the dotted line) or a copy of $\mathfrak{D}_{T} \otimes_{\mathbb{Z}_{p}[G]}\left(Z \oplus R_{1}\right)$ (for each row below the dotted line). By placing a vertical line at the point where the valuation is $\lambda_{2,1}(n)$, we are able to visually discern which elements of our $\mathfrak{O}_{T}$-basis of $\mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}$ lie in $\mathfrak{P}_{1}^{\lambda_{2,1}(n)}$, the image of $\mathfrak{P}_{2}^{n}$ under the trace. Let $\bullet$ 's represent basis elements which lie in $\mathfrak{P}_{1}^{\lambda_{2,1}(n)}$ while $*$ 's represent basis elements which do not lie in $\mathfrak{P}_{1}^{\lambda_{2,1}(n)}$. Let $M$ be the collection of $m$ 's (rows) which have as a member, a basis element in $\mathfrak{P}_{1}^{\lambda_{2,1}(n)}$. Now for each $m \in M$, let $\rho_{m}$ be the basis element in $\mathfrak{P}_{1}^{\lambda_{2,1}(n)}$ which has minimal valuation, and for each

$m \notin M$, let $\rho_{m}=0$. It is then easily seen that $\left\{\rho_{m} \mid m \in M\right\}$ generates $\mathfrak{P}_{1}^{\lambda_{2,1}(n)} / p \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$ over $\mathfrak{O}_{T} / p \mathfrak{O}_{T}[G]$. And if we let $\rho_{m, j}=\rho_{m} \cdot \eta_{j}$ where the $\eta_{j}$ 's were defined in Theorem 2, then $\left\{\rho_{m, j} \mid m \in M, j=1, \ldots, f\right\}$ generates $\mathfrak{P}_{1}^{\lambda_{2,1}(n)} / p \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$ over $\mathbb{F}_{p}[G]$.

Our next lemma determines the $\rho_{m}$ 's for $m=\left\lceil\frac{n-p b_{1}}{p^{2}}\right\rceil, \ldots, e_{0}+$ $\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1}-1$.

Lemma 5.
Let $s=\max \left\{0,(p-1)+\left\lceil\frac{\lambda_{2,1}(n)-p e_{0}-p\left\lceil\frac{n}{p^{2}}\right\rceil+p}{b_{1}}\right\rceil\right\}$. Then :
for $\left\lceil\frac{n-p b_{1}}{p^{2}}\right\rceil \leq m \leq\left\lceil\frac{\lambda_{2,1}(n)-p b_{1}}{p}\right\rceil-1, v_{1}\left((\sigma-1)^{p-1} \gamma_{m}\right)<\lambda_{2,1}(n)$, $\rho_{m}=0$;
for $\left\lceil\frac{\lambda_{2,1}(n)-p b_{1}}{p}\right\rceil \leq m \leq\left\lceil\frac{\lambda_{2,1}(n)-(p-1) b_{1}}{p}\right\rceil-1, \rho_{m}=(\sigma-1)^{p-1} \gamma_{m}$; for $\left\lceil\frac{\lambda_{2,1}(n)-(p-1) b_{1}}{p}\right\rceil \leq m \leq\left\lceil\frac{\lambda_{2,1}(n)-(p-2) b_{1}}{p}\right\rceil-1, \rho_{m}=$ $(\sigma-1)^{p-2} \gamma_{m}$;
for $\left\lceil\frac{\lambda_{2,1}(n)-(s+2) b_{1}}{p}\right\rceil \leq m \leq\left\lceil\frac{\lambda_{2,1}(n)-(s+1) b_{1}}{p}\right\rceil-1, \rho_{m}=$ $(\sigma-1)^{s+1} \gamma_{m} ;$
and for $\left\lceil\frac{\lambda_{2,1}(n)-(s+1) b_{1}}{p}\right\rceil \leq m \leq e_{0}+\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1}-1, \rho_{m}=(\sigma-1)^{s} \gamma_{m}$.
Proof. - This is an easy exercise using (12).
In our next lemma we show that for each row below the dotted line, $\rho_{m}$ lies strictly to the right of $\alpha_{m}$.

Proof. - By (10) $v_{1}\left(\alpha_{m}\right)=p\left(b_{1}+m\right)$. All we need to show is that $\lambda_{2,1}(n)>p\left(b_{1}+\left\lceil\frac{n-p b_{1}}{p^{2}}\right\rceil-1\right)$. The proof breaks up into two cases : Case 1. If $b_{1} \geq \frac{e_{0}}{p-1}$ then by [20, Cor 29, Thm 33], $b_{2}=b_{1}+p e_{0}$, and one can easily check that the inequality is satisfied. Case 2. If $b_{1}<\frac{e_{0}}{p-1}$, consider the Kummer case where $\zeta_{p} \in K_{0}, \zeta_{p}$ denotes a primitive $p$ th root of unity. By [20, Thm 32], $b_{2}=\frac{p^{2} e_{0}}{p-1}-p j+b_{1}$ for $b_{1} \leq j \leq \Psi_{K_{1} / K_{0}}\left(\frac{e_{0}}{p-1}\right)$ where $\Psi_{K_{1} / K_{0}}$ is defined in [18] pg 73. Using [18] and the fact that $b_{1} \leq$ $\frac{e_{0}}{p-1}$, it is easily shown that $\Psi_{K_{1} / K_{0}}\left(\frac{e_{0}}{p-1}\right)=p\left(\frac{e_{0}}{p-1}-b_{1}\right)+b_{1}$. And so clearly, $b_{2} \geq\left(\frac{p^{2} e_{0}}{p-1}-p \Psi_{K_{1} / K_{0}}\left(\frac{e_{0}}{p-1}\right)+b_{1}\right)=\left(p^{2}-p+1\right) b_{1}$. Now, it is an easy exercise to check that this inequality implies the desired inequality.

In the other case, where $\zeta_{p} \notin K_{0},\left[K_{0}\left(\zeta_{p}\right): K_{0}\right]=d$ for some $d \mid p-1$, and $K_{2}\left(\zeta_{p}\right) / K_{0}\left(\zeta_{p}\right)$ is a cyclic fully ramified extension of degree $p^{2}$ with lower ramification numbers, $b_{2}^{\prime}=d b_{2}, b_{1}^{\prime}=d b_{1} 20$, Thm 15]. Clearly $b_{2}^{\prime} \geq\left(p^{2}-p+1\right) b_{1}^{\prime}$ implies $b_{2} \geq\left(p^{2}-p+1\right) b_{1}$, from which we can, once again, deduce the desired inequality.

As a result of Lemma 6, for each $m=\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1}, \ldots,\left\lceil\frac{n-p b_{1}}{p^{2}}\right\rceil-1$, $v_{1}\left(\rho_{m}\right)>v_{1}\left(\alpha_{m}\right)$. Therefore it must be that $\rho_{m}=(\sigma-1)^{p-2-t_{m}} \beta_{m}+\alpha_{m}$; or $\rho_{m}=(\sigma-1)^{i_{m}+p-2-t_{m}} \beta_{m}$ for some $i_{m}, 1 \leq i_{m} \leq t_{m}$; or if $\lambda_{2,1}(n)>$ $v_{1}\left((\sigma-1)^{p-2} \beta_{m}\right)$, then $\rho_{m}=0$. In order to determine which of these is the case, we group the $m$ 's together according to the value of $t_{m}$. These groupings will be useful in verifying subsequent lemmas.

For $\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1} \leq m<\max \left\{\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1}, \lambda_{2,0}(n)-e_{0}-b_{1}\right\}$, the $\rho_{m}$ 's lie strictly to the right of $(\sigma-1)^{p-2-t_{m}} \beta_{m}+\alpha_{m}$, because $v_{1}\left((\sigma-1)^{p-2-t_{m}}\right.$ $\left.\beta_{m}+\alpha_{m}\right)<\lambda_{2,1}$. We determine these $\rho_{m}$ 's in the following lemma.

Lemma 7. - Let $r=\max \left\{0,\left\lfloor\frac{p^{2}\left(\lambda_{2,0}(n)-e_{0}\right)-n}{p b_{1}}\right\rfloor\right\}$, and for $j=$

Proof. - It is an easy calculation to show that for each $j=0, \ldots, r$, $s_{i}$ is the smallest power of $\sigma-1$ such that $v_{1}\left((\sigma-1)^{s_{i}} \rho_{m}\right) \geq \lambda_{2,1}(n)$ where $m=\left\lceil\frac{n-(p-j) p b_{1}}{p^{2}}\right\rceil$. It is also easy to check that for each $j=0, \ldots, r$, if for $m=\left\lceil\frac{n-(p-j-1) p b_{1}}{p^{2}}\right\rceil-1, v_{1}\left((\sigma-1)^{t} \rho_{m}\right) \geq \lambda_{2,1}(n)$, then for $m=\left\lceil\frac{n-(p-j) p b_{1}}{p^{2}}\right\rceil, v_{1}\left((\sigma-1)^{t+1} \rho_{m}\right) \geq \lambda_{2,1}(n)$. Therefore for each span of $m$ 's, $\left\lceil\frac{n-(p-j) p b_{1}}{p^{2}}\right\rceil \leq m \leq\left\lceil\frac{n-(p-j-1) p b_{1}}{p^{2}}\right\rceil-1$, $\rho_{m}=\tau_{m, s_{j}}$ or $\rho_{m}=\tau_{m, s_{j}-1}$, and if $\left\lceil\frac{n-(p-r) p b_{1}}{p^{2}}\right\rceil<\lambda_{2,0}(n)-e_{0}-b_{1}-1$,
then $s_{r}=r+1$. It is then, easy to check that $\lambda_{2,0}(n)=b_{1}+\left\lceil\frac{\lambda_{2,1}(n)-b_{1}}{p}\right\rceil$. The lemma quickly follows.

Step 3. In this step we construct generators of $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$ over $\mathbb{Z}_{p}[G]$. These generators are constructed to be compatible with the generators of $\mathfrak{P}_{1}^{\lambda_{2,1}(n)} / p \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}$ over $\mathbb{F}_{p}[G]$ given by the $\left\{\rho_{m, j} \mid m \in M, j=1, \ldots f\right\}$ in the previous step. In the next two lemmas, we construct an explicit basis for $\mathfrak{P}_{2}^{n}$ over $\mathfrak{O}_{T}$ in an analogous fashion to the construction in Lemma 2.

Lemma 9. - Let $\mu_{t}$ for $t=\left\lceil\frac{n}{p}\right\rceil, \ldots, p e_{0}+\left\lceil\frac{n}{p}\right\rceil-1$ be the element listed in (10), (11) and (12) such that $v_{1}\left(\mu_{t}\right)=t$. Then there are elements, $\left\{\nu_{a p+b_{2}}\right\}_{a \in \mathbb{Z}} \in K_{2}$, with $v_{2}\left(\nu_{a p+b_{2}}\right)=a p+b_{2}$ such that they have the following property :

Proof. - From (1) and (2), $T_{K_{2} / K_{1}}\left(\mathfrak{P}_{2}^{a p+b_{2}}\right)=T_{K_{2} / K_{1}}\left(\mathfrak{P}_{2}^{a p+b_{2}-1}\right)=$ $\cdots=T_{K_{2} / K_{1}}\left(\mathfrak{P}_{2}^{a p+b_{2}-(p-1)}\right)=\mathfrak{P}_{1}^{a+b_{2}}$. Therefore, for any $a$ there exists an element $\nu_{a p+b_{2}} \in \mathfrak{P}_{2}^{a p+b_{2}} / \mathfrak{P}_{2}^{a p+b_{2}+1}$ with the aforementioned property. It is easy to show as in Lemma 1 that for $i=0,1, \ldots, p-1$, $v_{2}\left(\left(\sigma^{p}-1\right)^{i} \nu_{a p+b_{2}}\right)=a p+(i+1) b_{2}$.

Clearly the elements $\left\{\left(\sigma^{p}-1\right)^{i} \nu_{a p+b_{2}}\right\}$ for $i=0,1, \ldots, p-1$ and $a \in$ $\mathbb{Z}$ have distinct valuations. As in Lemma 2, we may therefore select from this collection only those elements such that $0 \leq v_{2}\left(\left(\sigma^{p}-1\right)^{i} \nu_{a p+b_{2}}\right) \leq p^{2} e_{0}-1$, and from them form an $\mathfrak{O}_{T}$-basis of $\mathfrak{O}_{2}$. Using these elements, we construct a basis for $\mathfrak{P}_{2}^{n}$ over $\mathfrak{O}_{T}$ as in Lemma 2.

Lemma $10 .-$ Let $t_{a}=\left\lceil\frac{n-p a}{b_{2}}\right\rceil-2$. Then

We now change the basis of Lemma 10, making it more suitable for our needs. Using the fact that every element of (10), (11) and (12) which lies in $\mathfrak{P}_{1}^{\lambda_{2,1}(n)}$ has the form $(\sigma-1)^{i} \rho_{m}$ for some $m \in M$ and some $i \geq 0$, we see that for any $\nu_{a p+b_{2}}$ with $a<p e_{0}+\left\lceil\frac{n}{p}\right\rceil-b_{2}, T_{K_{2} / K_{1}}\left(\nu_{a p+b_{2}}\right)=(\sigma-1)^{i} \rho_{m}$ for some $m \in M$ and $i \geq 0$. If $T_{K_{2} / K_{1}}\left(\nu_{a p+b_{2}}\right)=(\sigma-1)^{i} \rho_{m}$ for $i>0$, then there is another $a^{\prime}$ such that $T_{K_{2} / K_{1}}\left(\nu_{a^{\prime} p+b_{2}}\right)=\rho_{m}$, and we may replace $\nu_{a p+b_{2}}$ by $\nu_{a p+b_{2}}-(\sigma-1)^{i_{a}} \nu_{a^{\prime} p+b_{2}}$. We do this for all $a<p e_{0}+\left\lceil\frac{n}{p}\right\rceil-b_{2}$. For every other $\mathfrak{D}_{T}$-basis element, $\tau$, given by Lemma 10, we replace $\tau$ by $\tau-\frac{1}{p} T_{K_{2} / K_{1}}(\tau)$. In this manner we end up with a collection of elements in $\mathfrak{P}_{2}^{n}$ with the following two properties: 1) The nonzero elements of this collection form an $\mathfrak{O}_{T}$-basis for $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$. 2) This $\mathfrak{O}_{T}$-basis for $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$ breaks up into two disjoint sets; the first set, which may be parametrized
by $m \in M$, lies in one to one correspondance under the trace map with the nonzero $\rho_{m}$, while the second set is annihilated by the trace, $T_{K_{2} / K_{1}}$.

For ease of notation, we relable the $\mathfrak{O}_{T}$-basis of $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}$ given in the previous paragraph. Each member of the first set, $\nu_{a p+b_{2}}$, where $T_{K_{2} / K_{1}}\left(\nu_{a p+b_{2}}\right)=\rho_{m}$ for a nonzero $\rho_{m}$, we denote by $\nu_{m}$ where $m \in M$ and $T_{K_{2} / K_{1}}\left(\nu_{m}\right)=\rho_{m}$. Each member of the second set, which is killed by the trace, is denoted by $\nu_{m}$ for some $m \in\left\{0,1, \ldots, e_{0} p(p-1)\right\}-M$. Let $\eta_{1}, \eta_{2}, \ldots, \eta_{f}$ be the basis for $\mathfrak{D}_{T}$ over $\mathbb{Z}_{p}$ given in Theorem 2. Then $\nu_{m, j}=\eta_{j} \cdot \nu_{m}$ for $m \in M$ and $j=1, \ldots f$ is a $\mathbb{Z}_{p}$-basis for $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$.

In the following lemma, we show that the elements $\nu_{m, j}=\eta_{j} \cdot \nu_{m}$ for $m \in M$ and $j=1, \ldots f$ can be extended to a $\mathbb{Z}_{p}[G]$-module basis of $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$.

Lemma 11. - Let $\nu_{1}, \nu_{2}, \ldots, \nu_{s}, \nu_{s+1}, \ldots, \nu_{e_{0} f\left(p^{2}-p\right)}$ be elements of $\mathfrak{P}_{2}^{n}$ which form a $\mathbb{Z}_{p}$-basis for $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}$ and have the following properties :

Then $\nu_{1}, \nu_{2}, \ldots, \nu_{s}$ can be extended to a $\mathbb{Z}_{p}[G]$-basis of $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left[\frac{n}{p}\right]}$.
Proof. - Clearly, $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$ is a $\mathbb{Z}_{p}$-torsion free module which is annihilated by $T_{K_{2} / K_{1}}=\Phi_{p^{2}}(\sigma)$. As such, $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$ is a module over the principle ideal domain, $\mathbb{Z}_{p}\left[\zeta_{p^{2}}\right] \cong \frac{\mathbb{Z}_{p}[G]}{\Phi_{p^{2}}(\sigma)}=R_{2}$. It is well known then, that $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}$ is free as an $R_{2}$-module. By checking ranks, clearly $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil} \cong R_{2}^{e_{0} f}$ as $\mathbb{Z}_{p}[G]$ - modules. Let $x_{1}, x_{2}, \ldots, x_{e_{0} f}$ be elements of $\mathfrak{P}_{2}^{n}$ which form a $\mathbb{Z}_{p}[G]$-basis of $\mathfrak{P}_{2}^{n} / \mathfrak{P}^{\left[\frac{n}{p}\right\rceil}$. So for each $j, \mathbb{Z}_{p}[G] x_{j} \cong R_{2}$, and $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}=\sum_{j=1}^{e_{0} f} \mathbb{Z}_{p}[G] x_{j} \cong R_{2}^{e_{0} f}$. Then because the $x_{j}$ form a $\mathbb{Z}_{p}[G]$ basis of $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$, for each $i=1,2, \ldots, s, \nu_{i}=\sum_{j=1}^{e_{0} f} f_{i, j}(\sigma) x_{j}+A_{i}$ for some $f_{i, j}(\sigma) \in \mathbb{Z}_{p}[G]$ and some $A_{i} \in \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$. Because the $\nu_{i}$ form a $\mathbb{Z}_{p}$-basis of
$\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$, for each $j=1,2, \ldots e_{0} f, x_{j}=\sum_{k=1}^{s} a_{j, k} \nu_{k}+\sum_{k=s+1}^{e_{0} f\left(p^{2}-p\right)} a_{j, k} \nu_{k}+B_{j}$ for some $a_{j, k} \in \mathbb{Z}_{p}$ and $B_{j} \in \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}$. We can act via the trace on both of these expressions to find that :

Because $f_{1, j_{1}}(\sigma)$ is a unit in $\mathbb{Z}_{p}[G]$, we may change the $\mathbb{Z}_{p}[G]$-basis of $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$, replacing $x_{j_{1}}$ by $f_{1, j_{1}}(\sigma) x_{j_{1}}+\sum_{j \neq j_{1}} f_{1, j}(\sigma) x_{j}+A_{1}=\nu_{1}$. Now consider $i=2$. There is a $j_{2}$ such that $f_{2, j_{2}}(\sigma)$ is a unit in $\mathbb{Z}_{p}[G]$. If $j_{1}=j_{2}$ and $f_{2, j}$ is not a unit for any $j \neq j_{2}$, then $T_{K_{2} / K_{1}}\left(\nu_{2}\right)=$ $f_{2, j_{2}}(\sigma) T_{K_{2} / K_{1}}\left(\nu_{1}\right)+\sum_{j \neq j_{2}} f_{2, j}(\sigma) x_{j}+A_{2}$, and

\overline{T_{K_{2} / K_{1}}\left(\nu_{2}\right)} \equiv \overline{f_{2, j_{2}}(\sigma) T_{K_{2} / K_{1}}\left(\nu_{1}\right)}, \text { in } \frac{\mathfrak{P}_{1}^{\lambda_{2,1}}}{p \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}+(\sigma-1) \mathfrak{P}_{1}^{\lambda_{2,1}(n)}},
$$

which contradicts the fact that the $\nu_{i}$ are in one to one correspondance under $T_{K_{2} / K_{1}}$ with a $\mathbb{F}_{p}[G / H]$ - basis of $\mathfrak{P}_{1}^{\lambda_{2,1}(n)} / p \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$. Therefore we may assume that $j_{2} \neq j_{1}$ and replace $x_{j_{2}}$ by $f_{2, j_{2}}(\sigma) x_{j_{2}}+\sum_{j \neq j_{2}} f_{2, j}(\sigma) x_{j}+A_{2}=\nu_{2}$.

Clearly we can continue this process until we have replaced $s$ elements of our $\mathbb{Z}_{p}[G]$-basis of $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$ by $\nu_{1}, \nu_{2}, \ldots, \nu_{s}$. This proves the lemma.

As a result of this lemma, we may conclude that there is a $\mathbb{Z}_{p}[G]$ basis of $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$ consisting of elements $\nu_{m, j}$ for $m=-b_{1}, \ldots, e_{0}-b_{1}-1$, $j=1, \ldots, f$, such that

$$
\begin{equation*}
T_{K_{2} / K_{1}}\left(\nu_{m, j}\right)=\rho_{m} \cdot \eta_{j} \stackrel{\text { defn }}{=} \rho_{m, j}, \tag{14}
\end{equation*}
$$

the nonzero $\rho_{m, j}$ constituting an $\mathbb{F}_{p}[G]$ - basis of $T_{K_{2} / K_{1}}\left(\mathfrak{P}_{2}^{n}\right) / p \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}$.

## Step 4. The main result

In the following proof we make liberal use of the arguments in [5] §8A, $\S 34 \mathrm{~B} \& \S 34 \mathrm{C}]$. As in the proof of Lemma $11, \mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil} \cong R_{2}^{e_{0} f}$ as $\mathbb{Z}_{p}[G]-$ modules. Let $\nu_{m, j}$ be the $\mathbb{Z}_{p}[G]$-module basis of $\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}$ given in (14). Then

$$
\begin{equation*}
\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}=\sum_{m=\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1}}^{e_{0}+\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1}-1} \sum_{j=1}^{f} \mathbb{Z}_{p}[G] \nu_{m, j} \stackrel{\eta}{\cong} R_{2}^{e_{0} f} \tag{15}
\end{equation*}
$$

From now on we will suppress the range of values that $m$ and $j$ take and simply refer to $\sum_{m}$ and $\sum_{j}$ instead of $\sum_{m=\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1}}^{e_{0}+\left\lceil\frac{n}{p^{2}}\right\rceil-b_{1}-1}$ and $\sum_{j=1}^{f}$. Let $\iota$ be the inclusion map and $\pi$, the projection map. We have the following $\mathbb{Z}_{p}[G]$ exact short sequence,

$$
\begin{equation*}
0 \rightarrow \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil} \xrightarrow{\iota} \mathfrak{P}_{2}^{n} \xrightarrow{\eta \circ \pi} R_{2}^{e_{0} f} \rightarrow 0 \tag{16}
\end{equation*}
$$

which determines an element $\xi$ in $E x t_{\mathbb{Z}_{p}[G]}^{1}\left(\mathfrak{P}_{2}^{n} / \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}, \mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}\right)$. Let $\left\{z_{m, f}\right\}$ be indeterminates with $\sum_{m} \sum_{j} \mathbb{Z}_{p}[G] z_{m, j}$ a free $\mathbb{Z}_{p}[G]$-module and let $y_{m, j}=\Phi_{p^{2}}(\sigma) z_{m, j}$. Let $\gamma \in \operatorname{Hom}_{\mathbb{Z}_{p}[G]}\left(\sum_{m} \sum_{j} \mathbb{Z}_{p}[G] z_{m, j}, \mathfrak{P}_{2}^{n}\right)$ be induced by $\gamma\left(z_{m, j}\right)=\nu_{m, j}$ which in turn induces $\mu \in \operatorname{Hom}_{\mathbb{Z}_{p}[G]}\left(\sum_{m} \sum_{j} \mathbb{Z}_{p}[G] y_{m, j}\right.$,
$\left.\mathfrak{P}_{1}^{\left\lceil\frac{n}{p}\right\rceil}\right)$ such that $\mu\left(y_{m, j}\right)=\rho_{m, j}$. We have the following $\mathbb{Z}_{p}[G]$ commutative diagram,

$$
\begin{array}{rllllll}
0 & \rightarrow \sum_{m} \sum_{j} \mathbb{Z}_{p}[G] y_{m, j} & \rightarrow & \sum_{m} \sum_{j} \mathbb{Z}_{p}[G] z_{m, j} & \rightarrow & R_{2}^{e_{0} f} & \rightarrow 0 \\
\mu \downarrow \\
& & & & & \\
& & & \downarrow & & \\
0 & \mathfrak{P}_{1}^{\left[\frac{n}{p}\right]} & & \iota & \mathfrak{P}_{2}^{n} & \xrightarrow{\eta \circ \pi} & R_{2}^{e_{0} f}
\end{array} \rightarrow 0 .
$$

As in [5] pg 174-6, $\S 34 \mathrm{C}$, the $\mathbb{Z}_{p}[G]$ - module structure of $\mathfrak{P}_{2}^{n}$ is completely determined by

$$
\bar{\mu} \in \frac{\operatorname{Hom}_{\mathbb{Z}_{p}[G]}\left(\sum_{m} \sum_{j} \mathbb{Z}_{p}[G] y_{m, j}, \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}\right)}{p \operatorname{Hom}_{\mathbb{Z}_{p}[G]}\left(\sum_{m} \sum_{j} \mathbb{Z}_{p}[G] y_{m, j}, \mathfrak{P}_{1}^{\left[\frac{n}{p}\right\rceil}\right)}
$$

which is completely determined by the matrix A mapping $\rho_{m, j}$ to its expression in terms of the basis elements of Theorem 2. Outside of the case where a column of A contains a $\rho_{m, j}=(\sigma-1)^{p-2-t_{m}} \beta_{m, j}+\alpha_{m, j} \in R_{1} \oplus Z$ (as in Lemma 8), it is easy to see that any row and column of this matrix which intersect at a nonzero $\rho_{m, j}$ are zero elsewhere. As a result, a copy of $\left(R_{2}, E ; \lambda^{i}\right)$ if $\rho_{m, j}=(\sigma-1)^{i} \gamma$ or $\left(R_{2}, R_{1} ; \lambda^{i}\right)$ if $\rho_{m, j}=(\sigma-1)^{i} \beta_{m}$ decomposes off of $\mathfrak{P}_{2}^{n}$. In the case where a column contains a $\rho_{m, j}=$ $(\sigma-1)^{p-2-t_{m}} \beta_{m, j}+\alpha_{m, j} \in R_{1} \oplus Z$, it is easy to see that the column is zero outside of the two places where $(\sigma-1)^{p-2-t_{m}} \beta_{m, j}$ and $\alpha_{m, j}$ appear, and that the two rows intersecting the column at $(\sigma-1)^{p-2-t_{m}} \beta_{m, j}$ and $\alpha_{m, j}$ are zero elsewhere, and as a result a copy of $\left(R_{2}, Z \oplus R_{1} ; 1 \oplus \lambda^{p-2-t_{m}}\right)$ decomposes off of $\mathfrak{P}_{2}^{n}$.

Therefore using Lemmas 5, 7 and 8, one arrives at Theorem 1.

## 4. Remarks.

One can generate cyclic extensions of degree $p^{2}$ with prescribed lower ramification numbers using the results of Maus [13], Miki [14] and Wyman [20]. In particular, as we did in Lemma 6, one can use [20] Thm 32.

We observe that using our main result and [16] Table 2, one can generalize [16] Thm 3, unconditionally determining the modular representation
given by $\mathfrak{P}_{2}^{n} / p \mathfrak{P}_{2}^{n}$. One can also use our main result to prove a global theorem, as was done in [16] Thm 5, generalizing a Theorem of Yokoi [21] Thm 3.

Finally we observe that only $3 p$ of the possible $4 p+1$ indecomposable modules given by Heller and Reiner [5] Thm 34.32, actually appear in the decomposition of the ring of integers of a local field. What are the intrinsic reasons for this? When $G$ is a $p$-group, neither cyclic of order $p$ nor cyclic of order $p^{2}$, there are infinitely many inequivalent indecomposable $\mathbb{Z}_{p}[G]$ modules [5] pg 690. Which of these can occur in a fractional ideal of a local number field extension, $L / K$, with $\operatorname{Gal}(L / K) \cong G$ ? The answer to these interesting questions, even under some weak arithmetic condition, should have a profound effect upon future results concerning the the $\mathbb{Z}_{p}[G]$ - module structure of $\mathfrak{V}_{L}$.
