# Small time periodic solutions of fully nonlinear telegraph equations in more spatial dimensions

Abstract. - The solution to the problem is expressed by means of a couple of new dependent variables - the time derivative of the desired solution and a function independent of time, which is the trace of the solution in a fixed time. This simple device makes it possible to prove the existence of a time-periodic solution without encountering the "loss of derivatives" phenomenon.

The result provides a small smooth solution, unique in a neighbourhood of zero, for any equation which is a perturbation of a suitable linear telegraph equation at least by quadratic terms which can involve any derivatives up to order two of the unknown function.

Key words : Hyperbolique equation with dissipation, time-periodic solutions.

Résumé. - On démontre l'existence d'une solution périodique en temps pour une équation hyperbolique du deuxième ordre avec dissipation et une force périodique mais petite et avec une non-linéarité composée de dérivées de la variable dépendante dont l'ordre ne dépasse pas deux.

Le phénomène de «la perte des dérivées» est détourné par une simple transformation de la variable dépendante.

## 1. INTRODUCTION

Denoting the number of spatial variables by $n$ we set

$$
\bar{n}=\left[\frac{n+1}{2}\right]+1 \quad \text { and } \quad M=\bar{n}+3
$$

where [ ] is used to denote the integer part of a real number. With the usual notation for derivatives we write

$$
\mathrm{J}(u)=\left\{\partial_{x}^{\alpha} \partial_{t}^{p} u ;|\alpha|+p \leqq 2, \alpha=\left(\alpha_{1}, \ldots, \alpha_{n}\right)\right\}
$$

to denote the jet of all derivatives up to order 2.
Let $\mathbf{G}=\mathrm{G}(\zeta) ; \zeta=\left\{\zeta_{\alpha}^{p}\right\}_{|\alpha|+p \leqq 2}$ be a function on a neighbourhood $\mathscr{N}\left(\eta_{0}\right)=\left\{\zeta ;\left|\zeta_{\alpha}^{p}\right|<\eta_{0}\right.$ for $\left.|\alpha|+p \leqq 2\right\}$ of 0 in $\mathrm{R}^{d}, d=\binom{n+3}{2}$. We shall suppose that $G \in C^{M+1}\left(\mathscr{N}\left(\eta_{0}\right)\right), G(0)=0$ and that the functions

satisfy

Throughout the paper $\Omega$ will denote an open and bounded domain in $\mathrm{R}^{n}$ of class $\mathrm{C}^{\mathrm{M}+1}$. We shall show the existence of a classical solution to the problem

\mathrm{A} u+\partial_{t} u+\kappa \partial_{t}^{2} u+\sum_{r=1}^{n} \kappa_{r} \partial_{x_{r}} \partial_{t} u+\mathrm{G}(\mathrm{~J} u)+f=0 \text { in } \Omega \times \mathrm{R},  \tag{1.1}\\
u(x, t)=0 \text { for } x \in \partial \Omega, \quad t \in \mathrm{R},  \tag{1.2}\\
u(x, t)=u(x, t+2 \pi) \text { for } x \in \Omega, \quad t \in \mathrm{R} \tag{1.3}
\end{gather*}
$$

where $\kappa$ and all $\kappa_{r}$ are constants,

$$
\begin{equation*}
(\mathrm{A} u)(x, t)=\sum_{|\alpha|,|\beta| \leqq 1}(-1)^{|\alpha|} \partial_{x}^{\alpha}\left(a_{\alpha \beta}(x) \partial_{x}^{\beta} u(x, t)\right) \tag{1.4}
\end{equation*}
$$

and $f$ is a smooth and small function. The detailed assumptions on A and $f$ along with the main result will be given in the next section.

Let us note that those assumptions will be satisfied for $A=-\Delta$ and $\kappa_{r}=0$. Hence the equation

$$
-\Delta u+\partial_{t} u+\kappa \partial_{t}^{2} u+\mathrm{G}\left(\partial_{x_{i}} \partial_{x_{j}} u, \partial_{x_{i}} \partial_{t} u, \partial_{x_{i}} u, \partial_{t} u, u\right)+f=0
$$

has a unique small classical solution which is periodic in time with period $2 \pi$ and which satisfies the Dirichlet boundary condition provided that $f$ is $2 \pi$-periodic, sufficiently smooth and small.

In one spatial variable this problem was studied by P. H. Rabinowitz [7], with the help of a Moser theorem to overcome the "loss of derivatives"
phenomenon, see [7], p. 16, encountered when the usual Newton iterative procedure is applied. In this connection see also [2], where even a bifurcation problem is treated.

The solution $u$ to (1.1)-(1.3) will be written in the form

$$
u(x, t)=\int_{0}^{t} v(x, \tau) d \tau+b(x)
$$

where, obviously, $v=\partial_{t} u$ and, by virtue of $2 \pi$-periodicity of $u$ in $t, v$ satisfies $\int_{0}^{2 \pi} v(x, t) d t=0$.

This device makes avoiding the occurence of the "loss of derivatives" possible. Hence, by using Schauder's theorem, we are able to extend the result of [7] to more spatial variables and also to suppress the explicit appearance of the small parameter and to improve the assumptions on regularity of $f$ and G.
The idea of looking for $\partial_{t} u$ rather than for the solution $u$ itself is not new. It has been used in time periodic problems at least in those having the form where it is possible to separate the determination of $\partial_{t} u$ and the time independent component of the solution, see [6]. As far as the initialboundary value problems for (1.1) are concerned we refer to [8] and [9].
Equation (1.1) was taken in a form imitating the one-dimensional case of [3]. One of the crucial sufficient conditions for the existence, (2.2), has been taken over from [5].

## 2. BASIC NOTATIONS AND THE MAIN RESULT

The notations are standard. All functions are real-valued. The spaces $\mathrm{L}^{2}(\Omega)$ and $\mathrm{H}^{k}(\Omega)$ will be, respectively, equipped with the norms

$\mathrm{H}_{0}^{1}(\Omega)$ is the closure of $\mathrm{C}_{0}^{\infty}(\Omega)$ in $\mathrm{H}^{1}(\Omega)$. Denoting

\mathrm{Q}=\Omega \times(0,2 \pi)
$$

we equip the spaces $L^{2}(Q)$ and $H^{k}(Q)$, respectively, with the norms

\|u\|_{\mathrm{O}, \mathrm{Q}}=\left(\int_{0}^{2 \pi} \int_{\Omega}|u(x, t)|^{2} d x d t\right)^{1 / 2} \\
\|u\|_{k, \mathrm{Q}}=\max \left\{\left\|\partial_{x}^{\alpha} \partial_{t}^{p} u\right\|_{0, \mathrm{Q}} ;|\alpha|+p \leqq k\right\} .
\end{gathered}
$$

$\mathrm{C}_{2 \pi}^{\infty}(\Omega \times \mathrm{R})$ will be the space of $\mathrm{C}^{\infty}$ functions on $\Omega \times \mathrm{R}$ which are $2 \pi$-periodic in $t$.

By $\mathrm{H}^{k}(\mathrm{Q})$, the same symbol as above, we shall denote the completion of $C_{2 \pi}^{\infty}(\Omega \times R)$ in the norm $\|\cdot\|_{k, ~}$.

By $\mathrm{H}_{0}^{1}(\mathrm{Q})$ we denote the closure of $\left\{u \in \mathrm{C}_{2 \pi}^{\infty}(\Omega \times \mathrm{R}) ; u(., t) \in \mathrm{C}_{0}^{\infty}(\Omega)\right.$ for all $t \in \mathrm{R}\}$ in the norm $\|\cdot\|_{1, \mathrm{Q}}$.

In what follows, in agreement with the last two notations, all functions depending on $t$ are supposed to be $2 \pi$-periodic in $t$ without any particular reference to this fact; especially, there is no indication of the $2 \pi$-periodicity in $t$ in the notation of the spaces. As usual, the inner product in $\mathrm{L}^{2}(\mathrm{Q})$ is

(u, v)_{0}=\int_{0}^{2 \pi} \int_{\Omega} u(x, t) v(x, t) d x d t .
$$

For later use we also mention here the norm

$$
\|u\|_{k}=\max \left(\|u\|_{k, \mathrm{Q}},\left\|\partial_{t}^{k+1} u\right\|_{\mathrm{O}, \mathrm{Q}}\right)
$$

which was implicitely used in [7] and which is of a basic importance in the investigated problem.

Occasionally, the $C^{k}$ norms, denoted by $\|\cdot\|_{C^{k}(\bar{Q})}$ and $\|\cdot\|_{C^{k}(\bar{\Omega})}$ will be used. With the above choice of $\bar{n}$ the Sobolev inequality takes up the form

which, for simplicity, will be used with the same constants $\mathrm{C}_{\mathrm{s}}$ and $\bar{n}$ also in cases, where the domain $\Omega \subset R^{n}$ appears in lieu of Q .

For A given by (1.4) with $a_{\alpha \beta} \in \mathrm{C}_{*}^{p}(\Omega), p=\mathrm{M}-1+|\alpha|$, the class of functions which have continuous and bounded derivatives up to order $p$ on $\Omega$, we set

\mathrm{L}_{0} u=\mathrm{A} u+\partial_{t} u+\kappa \partial_{t}^{2} u+\sum_{r=1}^{n} \kappa_{r} \partial_{x_{r}} \partial_{t} u .
$$

Throughout the paper we shall suppose that there exist positive $\lambda$ and $\mathrm{C}_{0}$ such that

\left(\mathrm{L}_{0} u, \Lambda u\right)_{0} \geqq \mathrm{C}_{0}\|u\|_{1, \mathrm{Q}}^{2} \quad \text { for } \quad u \in \mathrm{H}^{2}(\mathrm{Q}) \cap \mathrm{H}_{0}^{1}(\mathrm{Q}), \tag{2.2}
\end{equation*}
$$

where

\begin{equation*}
\Lambda u=\partial_{t} u+\lambda u \tag{2.3}
\end{equation*}
$$

In particular, when $u$ is independent of $t$, (2.2) assumes the form, $u \in \mathrm{H}_{0}^{1}(\Omega)$,

$$
\begin{equation*}
\sum_{|\alpha|,|\beta| \leqq 1} \int_{\Omega} a_{\alpha \beta}(x) \partial_{x}^{\alpha} u(x) \partial_{x}^{\beta} u(x) d x \geqq\left(\mathrm{C}_{0} / \lambda\right)\|u\|_{1, \Omega}^{2} \tag{2.4}
\end{equation*}
$$

the condition of ellipticity of the bilinear form generated by A on $\mathrm{H}_{0}^{1}(\Omega) \times \mathrm{H}_{0}^{1}(\Omega)$.

With $A, \kappa, \kappa_{r}$ and G satisfying the assumptions listed above we have
Theorem 2.1. - There are $\varepsilon>0$ and $\eta>0$ such that for every $f$ with $\mid\|f\|_{\mathrm{M}-1}<\varepsilon$, there is a unique $u \in \mathrm{H}^{\mathrm{M}+1}(\mathrm{Q}),\|u\|_{\mathrm{M}, \mathrm{Q}}<\eta$, satisfying (1.1)-(1.3).

The proof is given in the next four sections. Relying on an auxiliary result whose proof is put off to Section 4 we give in the next section, Section 3, the proof of the main part of the above theorem. The auxiliary result is based upon the study of a linear problem which is postponed to Section 5. In the last section, Section 6, the proof of Theorem 2.1 is completed by showing the uniqueness and improving the regularity result of Section 3.

## 3. PROOF OF THEOREM 2.1 (FIRST PART)

In this section we introduce various sets and mappings, whose properties will be studied later, and we prove the existence of $u \in H^{M}(Q)$ satisfying (1.1)-(1.3). Two minor parts of the proof which will require the application of techniques developed in the next sections are postponed to the closing section, Section 6.

We set

$$
\mathrm{H}_{\#}^{k}(\mathrm{Q})=\left\{u \in \mathrm{H}^{k}(\mathrm{Q}) ; \int_{0}^{2 \pi} u(x, t) d t=0 \text { for all } x \in \Omega\right\}
$$

and

(\mathrm{I} v)(x, t)=\int_{0}^{t} v(x, \tau) d \tau
$$

for any $v \in H_{\#}^{k}(\mathrm{Q})$. Obviously, $\mathrm{I} v$ is also $2 \pi$-periodic in $t$ and, as we shall show; satisfies

\begin{equation*}
\|\mathrm{I} v\|_{\mathrm{O}, \mathrm{Q}} \leqq 2\|v\|_{\mathrm{O}, \mathrm{Q}} \tag{3.1}
\end{equation*}
$$

For any $z \in \mathrm{H}^{1}(0,2 \pi), z(0)=z(2 \pi)=0$ and almost all $\tau$ from $(0,2 \pi)$, we find easily after some simple arrangements that

$$
2 \frac{d}{d \tau}\left(z^{2}(\tau) \operatorname{cotg} \frac{\tau}{2}\right)=\left[2 z^{\prime}(\tau)\right]^{2}-z^{2}(\tau)-\left[2 z^{\prime}(\tau)-z(\tau) \operatorname{cotg} \frac{\tau}{2}\right]^{2}
$$

Since $z^{2}(\tau) \operatorname{cotg} \frac{\tau}{2} \rightarrow 0$ as $\tau \rightarrow 0_{+}$and $\tau \rightarrow 2 \pi_{-}$, we have, by integrating over $(\varepsilon, 2 \pi-\varepsilon)$ and letting $\varepsilon \searrow 0$,

This gives

from which, by setting $z(t)=\int_{0}^{t} y(\tau) d \tau$, it follows the following version of Wirtinger's inequality: for any $y \in \mathrm{~L}^{2}(0,2 \pi), \int_{0}^{2 \pi} y(\tau) d \tau=0$ it holds

\int_{0}^{2 \pi}\left(\int_{0}^{t} y(\tau) d \tau\right)^{2} d t \leqq 4 \int_{0}^{2 \pi} y^{2}(t) d t
$$

From this inequality (3.1) is easy to obtain by integrating over $\Omega$.
Let us denote the left-hand side of $(1.1)$ by $F(u)$, i.e.

and by $\mathrm{L}(g(\mathrm{~J}(u))) v$ its linearization at $u$, i.e.

\mathrm{L}(g(\mathrm{~J}(u))) v=\mathrm{L}_{0} v+\sum_{|\alpha|+p \leqq 2} g_{\alpha}^{p}(\mathrm{~J}(u)) \partial_{x}^{\alpha} \partial_{t}^{p} v

where $g(\mathrm{~J}(u))$ is short for $\left\{g_{\alpha}^{p}(J(u))\right\}_{|\alpha|+p \leqq 2}$.
For two positive $\varepsilon_{v}$ and $\varepsilon_{b}$ which are sufficiently small, and which will be fixed later, we set

\begin{aligned}
& \mathrm{V}\left(\varepsilon_{v}\right)=\left\{v \in \mathrm{H}_{\sharp}^{\mathrm{M}}(\mathrm{Q}) \cap \mathrm{H}_{0}^{1}(\mathrm{Q}) ;\|v\|_{\mathrm{M}, \mathrm{Q}} \leqq \varepsilon_{v}\right\}, \\
& \mathrm{B}\left(\varepsilon_{b}\right)=\left\{b \in \mathrm{H}^{\mathrm{M}}(\Omega) \cap \mathrm{H}_{0}^{1}(\Omega) ;\|b\|_{\mathrm{M}, \Omega} \leqq \varepsilon_{b}\right\} .
\end{aligned}
$$

For any $v \in \mathrm{~V}\left(\varepsilon_{v}\right)$ and $b \in \mathbf{B}\left(\varepsilon_{b}\right)$ we have $\partial_{t}(\mathbf{I} v+b)=v$, since $b$ is independent of $t$, and thus simple calculations give

We now express $\mathrm{F}(\mathrm{I} v+b)(., 0)$, the trace of $\mathrm{F}(\mathrm{I} v+b)$ on $\Omega \times\{0\}$, in a convenient form. This will be achieved in (3.5). We begin by arranging
the components of $\mathrm{J} \boldsymbol{u}$ like this

\mathrm{J} u=\left\{\partial_{x}^{\beta} u, \partial_{x}^{\gamma} \partial_{t}^{p} u\right\}, \quad|\beta| \leqq 2, \quad|\gamma|+p \leqq 2, \quad p \geqq 1,
$$

so that the derivatives with respect to $x$ come first. Denoting

\mathrm{J}_{x}^{2} u=\left\{\partial_{x}^{\beta} u\right\}_{|\beta| \leqq 2} \\
\mathbf{J}^{1} u=\left\{\partial_{x}^{\gamma} \partial_{t}^{p-1} u\right\}_{|\gamma|+p \leqq 2, p \leqq 1}
\end{gathered}
$$

so that $\mathbf{J}^{1} u$ contains at most first derivatives of $u$, we have

\mathbf{J} u=\left\{\mathbf{J}_{x}^{2} u, \mathbf{J}^{1} \partial_{t} u\right\}
$$

Thus

\mathrm{J}(\mathrm{I} v+b)=\left\{\mathrm{J}_{x}^{2}(\mathrm{I} v+b), \mathrm{J}^{1} v\right\}
$$

and

$$
\begin{equation*}
\mathrm{J}(\mathrm{I} v+b)(x, 0)=\left\{\mathrm{J}_{x}^{2} b(x),\left(\mathrm{J}^{1} v\right)(x, 0)\right\} \tag{3.3}
\end{equation*}
$$

since for $t=0$, as it is the case, all terms containing the integral disappear.
Owing to the assumptions on $\Omega, a_{\alpha \beta}$ and (2.4), A can also be considered as a linear isomorphism of $H^{m}(\Omega) \cap H_{0}^{1}(\Omega)$ onto $H^{m-2}(\Omega)$ for any $m$, $2 \leqq m \leqq M+1$, see Theorem 9.8 in [1]. We make use of it by referring to the inequality

\left\|\mathrm{A}^{-1} \varphi\right\|_{m, \Omega} \leqq \mathrm{C}_{\mathrm{A}}\|\varphi\|_{m-2}, \Omega \tag{3.4}
\end{equation*}

Eventually, as the last notation of this section, we put

\Phi(b, v)=-\mathrm{A}^{-1}(v(., 0)+\kappa & \partial_{t} v(., 0) \\
& \left.+\sum_{r=1}^{n} \kappa_{r} \partial_{x_{r}} v(., 0)+\mathrm{G}\left(\mathrm{~J}_{x}^{2} b,\left(\mathrm{~J}^{1} v\right)(., 0)\right)+f(., 0)\right)
\end{aligned}
$$

which satisfies

$$
\begin{equation*}
\mathrm{F}(\mathrm{I} v+b)(., 0)=\mathrm{A}(b-\Phi(b, v)) \tag{3.5}
\end{equation*}
$$

as we immediately verify using (3.3).
The following lemma is a corner-stone of the proof of Theorem 2.1 and will be proved in the next section.

Lemma 3.1. - There exist positive $\varepsilon_{b}, \varepsilon_{v}$ and $\varepsilon$ such that for any $f$ with $\left\|\|f\|_{M-1}<\varepsilon\right.$ it holds:
(i) For every $b \in \mathrm{~B}\left(\varepsilon_{b}\right)$ there is a unique $v \in \mathrm{~V}\left(\varepsilon_{v}\right)$ satisfying

\left(\mathrm{L}(g(\mathrm{~J}(\mathrm{I} v+b))) v+\partial_{t} f, \varphi\right)_{0}=0, \quad \forall \varphi \in \mathrm{H}_{\#}^{0}(\mathrm{Q}) \tag{3.6}

when this $v$ is denoted by $v(b)$, then

(ii) The mapping $b \rightarrow \Phi(b, v(b))$ has a fixed point in $\mathbf{B}\left(\varepsilon_{b}\right)$.

Proof of Theorem 2. 1. - By part (ii) of Lemma 3.1 there is $b \in \mathbf{B}\left(\varepsilon_{b}\right)$ satisfying $b=\Phi(b, v(b))$, which, by (3.5) means

for $u=\mathrm{I} v(b)+b$. By (3.2) and part (i) of Lemma 3.1 this function $u$ satisfies

$$

which, since obviously $\partial_{t} \mathrm{~F}(u) \in \mathrm{H}_{\ddagger}^{0}(\mathrm{Q})$, implies $\partial_{t} \mathrm{~F}(u)=0$. In virtue of (3.8) we have $\mathrm{F}(u)=0$; i.e. (1.1)-(1.3) are satisfied. Obviously, $u \in \mathrm{H}^{\mathrm{M}}(\mathrm{Q})$ and $u_{t}=v \in \mathrm{H}^{\mathrm{M}}(\mathrm{Q})$. Thus the proof of Theorem 2.1 will be complete if we show the uniqueness and prove also that $\partial_{x}^{\alpha} u \in \mathrm{~L}^{2}(\mathrm{Q})$ for $|\alpha|=\mathrm{M}+1$. This is postponed to Section 6.

## 4. PROOF OF LEMMA 3.1

In what follows $\gamma$ will stand for a collection of functions $\gamma_{\alpha}^{p},|\alpha|+p \leqq 2$. For a given $\gamma$ we set

This proves (4.16) since the estimates of the linear part of $\Phi$ are straightforward. Considering $b \rightarrow \Phi(b, v(b))$ as a mapping of $\mathrm{B}\left(\varepsilon_{b}\right)$ into itself, we get a fixed point by Schauder's theorem. This completes the proof of Lemma 3.1.
Remark 4.1. - The proof has been carried out on condition that $\varepsilon_{b}$ and $\varepsilon_{v}$ satisfy (4.1), (4.4), (4.13) and (4.14) and $f$ satisfies (4.5) and (4.15). It is possible to choose $\varepsilon_{v}$ and $\varepsilon_{b}$ so small that all four inequalities are satisfied. Since $\max \left(\left\|\left\|f_{t}\right\|_{M-2},\right\|\|f\| \tilde{M}_{-2}\right) \leqq \mid\|f\|_{M-1}$, (4.5) and (4.15) can be satisfied by taking $\varepsilon$ sufficiently small.

## 5. LINEAR PROBLEM

In this section we give the proof of Lemma 4.1. The technique, a Galerkin approximation, is rather standard. Only $m=\mathbf{M}$ is dealt with since the case $m=\mathbf{M}-1$ is even simpler to treat. Thus, it is to be proved that for every $\gamma$ with $\left\|\|\gamma\|_{M-2}<\delta, \delta\right.$ sufficiently small, and any $h$, $\|h\|_{M-2}<\infty$, there exists a unique $v \in \mathrm{H}_{\ddagger}^{M}(\mathrm{Q}) \cap \mathrm{H}_{0}^{1}(\mathrm{Q})$ satisfying

where K depends only on $\delta$.
We denote by $\omega_{s}$ and $\lambda_{s}$ the sequence of all eigenfunctions and eigenvalues of the problem

[Due to the assumptions on $\Omega$ and $A$ we even have $\omega_{n} \in \mathbf{H}^{\mathrm{M}+1}(\Omega)$.] Moreover, we shall suppose

Further, we set $e_{j}(t)=(\pi)^{-1 / 2} \sin j t$ for $j=1,2, \ldots$, and $e_{j}(t)=(\pi)^{-1 / 2} \cos j t$ for $j=-1,-2, \ldots$, so that the constant function is not considered.

For positive integers N and S we set

\end{gathered}

and denote by $\Pi^{N}$ (resp. $\Pi_{S}^{N}$ ) the orthogonal projectors on $X^{N}$ (resp. $X_{S}^{N}$ ) in $L^{2}(\mathrm{Q})$ with the inner product $(,)_{0}$ defined in Section 2.

The proof of Lemma 4.1 is divided into three steps. We start with an auxiliary estimate in step 1 . In step 2 an approximating solution from $X_{s}^{N}$ is found and its estimate in $\mathrm{H}^{2}(\mathrm{Q})$ is obtained. Letting $\mathrm{S} \rightarrow \infty$ we get an approximating solution which, as we show in step 3, is even an element of $H^{M}(\mathrm{Q})$. When an estimate of this solution in $\|\cdot\|_{\mathrm{M}, \mathrm{Q}}$ is obtained, we get $v$ satisfying (5.1) and (5.2) by letting $\mathrm{N} \rightarrow \infty$.

STEP 1. - Let $1 \leqq k \leqq M$ and $v \in \mathbf{X}^{N} \cap \mathbf{H}^{k}(\mathbf{Q}) \cap \mathbf{H}_{0}^{1}(\mathbf{Q})$. Then

where $\Lambda$ is defined by (2.3) and $K_{k}^{*}$ will denote a constant dependent only on $k$ which can grow in each of the several stages of the proof. Integrating per partes (all functions are $2 \pi$-periodic in $t$ and no boundary terms therefore appear) we get, by virtue of (2.2),

We suppress the indexes of $\gamma_{\alpha}^{p}$ writing simply $\gamma$ instead and, integrating per partes, we obtain

At first, $I_{0}^{\alpha, p}$ will be dealt with. If $|\alpha| \leqq 1$, then the desired estimate is easily achieved after simple computations. For example, when $|\alpha|=1$ and

the estimate of $\mathrm{I}_{0}^{\alpha, p}$ has the form (5.4).
For $|\alpha|=2$, i. e. $p=0$, we must be more careful.
Since $\partial_{x}^{\alpha}=\partial_{x_{i}} \partial_{x_{j}}$ for some $i$ and $j$,

& =-\frac{1}{2}\left[\left(\left(\partial_{x_{i}} \gamma\right) \partial_{x_{j}} \partial_{t}^{k-1} v, \partial_{t}^{k} v\right)_{0}\right. \\
& \left.+\left(\left(\partial_{x_{j}} \gamma\right) \partial_{x_{i}} \partial_{t}^{k-1}, \partial_{t}^{k} v\right)_{0}\right] \\
& -\frac{1}{2}\left\{\left(\gamma \partial_{x_{j}} \partial_{t}^{k-1} v, \partial_{x_{i}} \partial_{t}^{k} v\right)_{0}\right. \\
& \left.+\left(\gamma \partial_{x_{i}} \partial_{t}^{k-1} v, \partial_{x_{j}} \partial_{t}^{k} v\right)_{0}\right\}

As above, the terms in [ ] can be directly estimated. The terms in $\}$ equal

which is also easy to estimate. Thus $I_{0}^{\alpha, p}$ is estimated in the form (5.4). On estimating $I_{s}^{\alpha, p}, s \geqq 1$, the following lemma will be applied.

Remark 5.1. - In other words, $\mathbf{H}^{l}(\mathbf{Q})$ is a modul over $\mathbf{H}^{r}(\mathrm{Q})$. Only for completeness we present the proof. For simplicity we set $m=n+1$. We
shall distinguish the following six cases:
(i) $l_{1}+m / 2<r$,
(ii) $l_{2}+m / 2<l$,
(iii) $l_{1}+m / 2=r, l_{2}+m / 2=l$,
(iv) $l_{1}+m / 2>r, l_{2}+m / 2=l$,
(v) $l_{1}+m / 2=r, l_{2}+m / 2>l$,
(vi) $l_{1}+m / 2>r, l_{2}+m / 2>l$.

Case (i). - By the Sobolev inequality $\left\|\mathrm{D}^{l_{1}} a\right\|_{\mathrm{C}(\overline{\mathrm{Q}})} \leqq \mathrm{C}_{\mathrm{S}}\|a\|_{\mathrm{r}, \mathrm{Q}}$. Estimating the first factor in $\left(\mathrm{D}^{l_{1}} a\right)\left(\mathrm{D}^{l_{2}} b\right)$ with the help of this, we get the estimate in the lemma.

Case (ii). - Entirely analogous, since now

Case (v). - Now

Case (vi). - We get $m>r$, when summing up the inequalities in (vi). By assumption, $r>m / 2$. Hence $\chi=1 /\left(\frac{2 r}{m}-1\right)>1$. Along with $p$ from $\left(\gamma_{2}\right)$ and $q$ from $\left(\delta_{2}\right)$ this $\chi$ satisfies

We now return to estimating $\mathrm{I}_{s}^{\alpha, p}, s \geqq 1$. The case $s=k$ we leave as the final stage of this step and we shall suppose $1 \leqq s \leqq k-1$ at first. This implies that $k$ must be at least 2. Obviously,

(b) Now let $k=\mathbf{M}$ and let us treat $s=\mathbf{M}-1$. Then,

(c) Further, let $k=\mathbf{M}$ and $1 \leqq s \leqq \mathbf{M}-2$. Then, as above,

By Lemma $5.1 \quad\left(a=\partial_{t} \gamma, \quad b=\partial_{x}^{\alpha} \partial_{t}^{p+1} v, \quad D^{l_{1}}=\partial_{t}^{s-1}, \quad D^{l_{2}}=\partial_{t}^{M-2-s}\right.$, $\left.r=\mathrm{M}-3=\bar{n}, l_{1}+l_{2}=s-1+\mathbf{M}-2-s=\mathbf{M}-3\right)$,

\mathrm{J}_{s}^{\alpha, p} \leqq \sigma_{\mathrm{M}-3}\left\|\partial_{t} \gamma\right\|_{\mathrm{M}-3, \mathrm{Q}}\left\|\partial_{x}^{\alpha} \partial_{t}^{p+1} v\right\|_{\mathrm{M}-3, \mathrm{Q}} \leqq \sigma_{\mathrm{M}-3} \mid\|\gamma\|_{\mathrm{M}-2}\|v\|_{\mathrm{M}, \mathrm{Q}}
$$

and $I_{s}^{\alpha, p}$ again satisfies the estimate of type (5.4).
Finally, we estimate $I_{k}^{\alpha, p}$. For $k=1$, transferring, if necessary, one derivative from $\partial_{x}^{\alpha} \partial_{t}^{p} v$, we get $\left|\left(\gamma \partial_{x}^{\alpha} \partial_{t}^{p} v, v\right)_{0}\right| \leqq \delta \mathrm{K}_{1}^{*}\|v\|_{1}^{2}, \mathrm{Q}$, the estimate of form (5.4). For $k \geqq 2$,

and, by Lemma 5.1 with $r=M-2$,

As $\Pi_{\mathbf{S}}^{\mathbf{N}} \mathrm{L}(\gamma)$ maps $\mathrm{X}_{\mathbf{S}}^{\mathbf{N}}$ into itself, (5.5) shows that there exists $v_{\mathbf{S}}^{\mathbf{N}} \in \mathbf{X}_{\mathbf{S}}^{\mathbf{N}}$ satisfying

Inserting $\varphi=-\Lambda \partial_{t}^{2} v_{\mathbf{S}}^{\mathrm{N}}$ in (5.6) and $v=v_{\mathbf{S}}^{\mathrm{N}}$ in (5.3) with $k=2$, we have after simple calculations, for $\delta$ small,

g_{\mathrm{S}}^{\mathrm{N}}=\partial_{t} v_{\mathrm{S}}^{\mathrm{N}}+\kappa \partial_{t}^{2} v_{\mathrm{S}}^{\mathrm{N}}+\sum_{r=1}^{n} \kappa_{r} \Pi_{\mathrm{S}}^{\mathrm{N}} \partial_{x_{r}} \partial_{t} v_{\mathrm{S}}^{\mathrm{N}}+\sum_{|\alpha|+p \leqq 2} \Pi_{\mathrm{S}}^{\mathrm{N}}\left(\gamma_{\alpha}^{p} \partial_{x}^{\alpha} \partial_{t}^{p} v_{\mathrm{S}}^{\mathrm{N}}\right)
$$

When, as above, $\hat{\kappa}=1+|\kappa|+\sum_{r=1}^{n}\left|\kappa_{r}\right|$, then

\end{equation*}

\left\|\Pi_{\mathrm{S}}^{\mathrm{N}}\left(\gamma_{\alpha}^{p} \partial_{x}^{\alpha} \partial_{t}^{p} v\right)\right\|_{\mathrm{O}, \mathrm{Q}} \leqq \| \gamma_{\alpha}^{p} \partial_{x}^{\alpha} \partial_{t}^{p} v & \|_{\mathrm{o}, \mathrm{Q}} \\
& \leqq \gamma_{\alpha}^{p}\left\|_{\mathrm{C}(\overline{\mathrm{Q}})}\right\| \partial_{x}^{\alpha} \partial_{t}^{p} v\left\|_{\mathrm{O}, \mathrm{Q}} \leqq \mathrm{C}_{\mathrm{S}}\left|\|\gamma \mid\|_{\mathrm{M}-2}\|v\|_{2, \mathrm{Q}} .\right.\right.
\end{aligned}
$$

Also here $\sigma$ (indexed and/or barred) is used to denote various constants independent of $\delta$ and $v$.

The norm $\left\|\partial_{t} v_{\mathrm{S}}^{\mathrm{N}}\right\|_{1, \mathrm{Q}}$ in (5.7) is close to $\left\|v_{\mathrm{S}}^{\mathrm{N}}\right\|_{2, \mathrm{Q}}$ in the sense that only the $L^{2}$-norm of second order derivatives, i.e. $\left\|\partial_{x}^{\beta} v_{\mathrm{S}}^{\mathrm{N}}\right\|_{0, \mathrm{Q}},|\beta|=2$, are missing. In obtaining these we shall apply the lemma, which will be useful also later.

Lemma 5.2. - Given $g \in \mathrm{X}^{\mathbf{N}}$ and a nonnegative integer $s \leqq \mathrm{M}-1$, let us suppose $g \in \mathrm{H}^{s}(\mathrm{Q})$. Then there is a unique $v \in \mathrm{X}^{\mathbf{N}} \cap \mathrm{H}_{0}^{1}(\mathrm{Q})$ with $\partial_{x}^{\beta} v \in \mathbf{H}^{s}(\mathrm{Q}),|\beta| \leqq 2$, satisfying $\mathrm{A} v=g$. Moreover,

The proof is straightforward. For $g \in \mathrm{X}^{\mathrm{N}}$ we have

Only for an easy reference in the next section we state:
Lemma 5.3. - The space $\mathrm{X}^{\mathrm{N}}$ in the preceding lemma can be substituted by $\mathrm{L}^{2}(\mathrm{Q})=\mathrm{H}^{0}(\mathrm{Q})$.
Really, for any $g \in \mathrm{~L}^{2}(\mathrm{Q})$ we can write

& \leqq \hat{\sigma}_{0}\left(\hat{\mathrm{\kappa}}\left\|\partial_{t} v_{\mathrm{S}}^{\mathrm{N}}\right\|_{1, \mathrm{Q}}+\delta \sigma_{6}\left\|v_{\mathrm{S}}^{\mathrm{N}}\right\|_{2, \mathrm{Q}}\right)+\hat{\sigma}_{\mathrm{o}}\|h\|_{\mathrm{O}, \mathrm{Q}} .
\end{aligned}
$$

From this, in virtue of (5.7), it follows

& \leqq \delta \hat{\sigma}_{0}\left(\hat{\kappa} K_{2}^{*}+\mathrm{C}_{0} \sigma_{6}\right)\left\|v_{\mathrm{S}}^{\mathrm{N}}\right\|_{2, \mathrm{Q}} \\
&+\hat{\sigma}_{0}\left(\hat{\kappa}(1+\lambda)+\mathrm{C}_{0}\right)\|h\|_{0} .
\end{aligned}
$$

By considering (5.7) and the least inequality we have

for $\delta$ sufficiently small. Letting $\mathrm{S} \rightarrow \infty$, we get $v^{\mathrm{N}} \in \mathrm{X}^{\mathrm{N}} \cap \mathbf{H}^{2}(\mathrm{Q}) \cap \mathbf{H}_{0}^{1}(\mathrm{Q})$ satisfying

\left\|v^{\mathrm{N}}\right\|_{2, \mathrm{Q}} \leqq \mathrm{~K}_{2}\|h\|_{0} .
\end{gather*}
$$

Also, (5.5) shows that $v^{\mathrm{N}}$ is unique. Besides, (5.12) is equivalent to

g^{\mathrm{N}}=\hat{c}_{t} v^{\mathrm{N}}+\kappa \partial_{t}^{2} v^{\mathrm{N}}+\sum_{r=1}^{n} \kappa_{r} \partial_{x_{r}} \partial_{t} v^{\mathrm{N}}+\sum_{\substack{|\alpha|+p=2 \\
p \geqq 1}} \Pi^{\mathrm{N}}\left(\gamma_{\alpha}^{p} \partial_{x}^{\alpha} \partial_{t}^{p} v^{\mathrm{N}}\right)+\Pi^{\mathrm{N}} h . \tag{5.15}
\end{gather*}
$$

Step 3. - We shall denote by $Z^{k}, 2 \leqq k$, a collection of functions for which

For any $\alpha,|\alpha| \leqq 2, \partial_{x}^{\alpha}$ is a continuous map of $Z^{k}$ into $H^{k-2}(\mathrm{Q})$. On the other hand (5.10) shows that $A^{-1}$ is a continuous map of $H^{k-2}(Q) \cap X^{N}$ into $Z^{k} \cap X^{N} \cap H_{0}^{1}(Q)$. With the help of Lemma 5.1 is therefore easy to see that

Further we shall proceed by induction. Suppose

Then just by looking on (5.15) we find that $g^{\mathbf{N}} \in \mathrm{H}^{k+1}(\mathrm{Q})$ (since $v^{\mathrm{N}} \in \mathrm{X}^{\mathbf{N}}$, there is no worry about derivatives with respect to $t$ ) and therefore $\mathrm{A}^{-1} g^{\mathrm{N}} \in \mathrm{Z}^{k+3} \cap \mathrm{X}^{\mathrm{N}} \cap \mathrm{H}_{0}^{1}(\mathrm{Q})$. In virtue of $(5.16)$ there is a unique $v \in \mathrm{Z}^{k+3} \cap \mathrm{H}_{0}^{1}(\mathrm{Q}) \cap \mathrm{X}^{\mathrm{N}}$ satisfying

Obviously, $v=v^{N}$ and thus $v^{N} \in Z^{k+3} \cap X^{N} \cap H_{0}^{1}(\mathrm{Q})$ which means $v^{\mathrm{N}} \in \mathrm{H}^{k+3}(\mathrm{Q}) \cap \mathrm{H}_{0}^{1}(\mathrm{Q}) \cap \mathrm{X}^{\mathrm{N}}$. This induction argument eventually gives $v^{\mathrm{N}} \in \mathrm{H}^{\mathrm{M}}$ (Q).

Let $L$ be any integer, $3 \leqq L \leqq M$. We shall suppose that

& \leqq \delta \mathrm{K}_{\mathrm{L}, l}^{*}\left\|v^{\mathrm{N}}\right\|_{\mathrm{L}, \mathrm{Q}}+\hat{\mathbf{K}}_{\mathrm{L}, l} \mid\|h\|_{\mathrm{L}-2} \tag{5.18}
\end{align*}
$$

is valid for $l=1$. Constants $\mathrm{K}_{\mathrm{L}, l}^{*}$ and $\hat{\mathbf{K}}_{\mathrm{L}, l}$ are positive and independent of $v^{\mathbf{N}}, h$, and $\gamma$. By induction we now show that (5.18) holds even for $l=\mathrm{L}$. To this end we start by supposing (5.18) holds with some $l, 1 \leqq l \leqq \mathrm{~L}-1$. Further, we give (5.12) the following form

g_{2}^{N}=\sum_{|\alpha|+p=2} \Pi^{\mathbb{N}}\left(\gamma_{\alpha}^{p} \partial_{x}^{\alpha} \partial_{t}^{p} v^{N}\right)
$$

applying $\partial_{t}^{\mathrm{L}-l-1}$ to (5.19), we have

\mathrm{A}\left(\partial_{t}^{\mathrm{L}-l-1} v^{\mathrm{N}}\right)=-\partial_{t}^{\mathrm{L}-l-1}\left(g_{1}^{\mathrm{N}}+g_{2}^{\mathrm{N}}-h\right) \tag{5.20}
\end{equation*}

It is easy to check that the inequality, $|\beta| \leqq l-1$,

\left\|\partial_{x}^{\beta} \partial_{t}^{\mathrm{L}-l-1} g_{1}^{\mathrm{N}}\right\|_{\mathrm{O}, \mathrm{Q}} \leqq \delta \mathrm{~K}_{\mathrm{L}, l+1}^{*}\left\|v^{\mathrm{N}}\right\|_{\mathrm{L}, \mathrm{Q}}+\hat{\mathrm{K}}_{\mathrm{L}, l+1}\|h\| \|_{\mathrm{L}-2} \tag{5.21}
\end{equation*}
$$

is a consequence of assumptions (5.17) and (5.18). Since $|\beta|+\mathrm{L}-l-1 \leqq \mathrm{~L}-2$, we can apply Lemma 5.1 to obtain

&=\left\|\Pi^{\mathrm{N}} \partial_{x}^{\beta} \partial_{t}^{\mathrm{L}-l-1}\left(\gamma_{\alpha}^{p} \partial_{x}^{\alpha} \partial_{t}^{p} v^{\mathrm{N}}\right)\right\|_{\mathbf{0 , Q}} \\
& \leqq \sigma_{\mathrm{L}-2}\left\|\gamma_{\alpha}^{p}\right\|_{\mathrm{L}-2, \mathrm{Q}}\left\|\partial_{x}^{\alpha} \partial_{t}^{p} v\right\|_{\mathrm{L}-2, \mathrm{Q}} \leqq \sigma_{\mathrm{L}-2} \delta\left\|v^{\mathrm{N}}\right\|_{\mathrm{L}, \mathrm{Q}}
\end{aligned}
$$

Obviously, $\left\|\partial_{t}^{\mathrm{L}-l-1} \partial_{x}^{\mathrm{B}} h\right\|_{\mathrm{O}, \mathrm{Q}} \leqq\|h\|_{\mathrm{O}, \mathrm{L}-2}$. Thus (5.11) with $s=l-1$ applied to (5.20) along with (5.21) and (5.22) yield
$\max \left\{\left\|\partial_{x}^{\beta} \partial_{t}^{\mathrm{L}-l-1} v^{\mathrm{N}}\right\|_{\mathrm{O}, \mathrm{Q}} ;|\beta| \leqq l+1\right\} \leqq \delta \mathrm{K}_{\mathrm{L}, l+1}^{*}\left\|v^{\mathrm{N}}\right\|_{\mathrm{L}, \mathrm{Q}}+\widehat{\mathrm{K}}_{\mathrm{L}, l+1} \mid\|h\|_{\mathrm{L}-2}$.
In particular, this shows that (5.18) holds also with $l+1$ in lieu of $l$. Hence, as said above, we can put $l=\mathrm{L}$ in (5.18) and, for $\delta$ small, obtain $\left\|v^{N}\right\|_{\mathrm{L}, \mathrm{Q}} \leqq \mathrm{K}_{\mathrm{L}}\|\mid h\|_{\mathrm{L}-2}$, which is (5.17) with L in place of $\mathrm{L}-1$. Hence $\left\|v^{N}\right\|_{M} \leqq \mathrm{~K}_{\mathrm{M}} \mid\|h\|_{\mathrm{M}-2}$. Letting $\mathrm{N} \rightarrow \infty$, we have $v$ satisfying (5.1) and (5.2) whose uniqueness follows from (5.5). This completes the proof of Lemma 4.1.

## 6. CONCLUSION OF THE PROOF OF THEOREM 2.1

We shall prove the uniqueness of $u$ found in Section 2. Let us suppose there are $u_{1}, u_{2} \in \mathrm{H}^{\mathrm{M}}(\mathrm{Q}) \cap \mathrm{H}_{0}^{1}(\mathrm{Q}),\left\|u_{i}\right\|_{\mathrm{M}, \mathrm{Q}}<\eta$, satisfying $\mathrm{F}\left(u_{i}\right)=0, i=1,2$. Since

\mathrm{F}\left(u_{1}\right)-\mathrm{F}\left(u_{2}\right)=\mathrm{L}_{0} \bar{u}+\sum_{|\alpha|+p \leqq 2} \bar{\gamma}_{\alpha}^{p} \partial_{x}^{\alpha} \partial_{t}^{p} \bar{u}
$$

with

\bar{u}=u_{1}-u_{2}, \quad \bar{\gamma}_{\alpha}^{p}=\int_{0}^{1} g_{\alpha}^{p}\left(\mathrm{~J}\left(u_{1}+\tau\left(u_{2}-u_{1}\right)\right)\right) d \tau
$$

by (2.2) we obtain

Simple estimates, completely imitating those leading to (5.5), show that the right-hand side of the last inequality can be estimated from below by $\mathrm{C}_{1}\|\vec{u}\|_{1, \mathrm{Q}}^{2}, \mathrm{C}_{1}>0$, provided that $\eta$ is sufficiently small. This proves uniqueness.

It remains to show $u \in H^{M+1}(Q)$. As explained in Section 3 this means only to show $\partial_{x}^{\alpha} u \in \mathrm{~L}^{2}(\mathrm{Q})$ for $|\alpha|=\mathbf{M}+1$. If $\mathrm{J}_{u}=\left\{\mathrm{J}_{x}^{2} u, \mathrm{~J}^{1} \partial_{t} u\right\}$ as in Section 3, then $u$ satisfies

\mathrm{A} u=-\mathrm{G}\left(\mathrm{~J}_{x}^{2} u, w\right)+f^{*} \tag{6.1}
\end{equation*}
$$

where

$$
-f^{*}=\partial_{t} u+\kappa \partial_{t}^{2} u+\sum_{r=1}^{n} \kappa_{r} \partial_{x_{r}} \partial_{t} u+f
$$

and

$$
w=\mathbf{J}^{1} \partial_{t} u
$$

Since $u_{t}=v,\|v\|_{\mathrm{M}, \mathrm{Q}}<\eta$ and $\|f\|_{\mathrm{M}-1, \mathrm{Q}}<\varepsilon$, we have

$$
\begin{equation*}
\left\|f^{*}\right\|_{M-1, Q} \leqq \hat{\kappa} \eta+\varepsilon \quad \text { and } \quad\|w\|_{M-1, Q}<\eta . \tag{6.2}
\end{equation*}
$$

We shall be concerned with a mapping $\Xi$ given by

$$
\Xi(\mathrm{U})=\mathrm{A}^{-1}\left(-\mathrm{G}\left(\mathrm{~J}_{x}^{2} \mathrm{U}, w\right)+f^{*}\right)
$$

on a ball $B=\left\{U \in Z^{M+1} \cap H_{0}^{1}(Q) ;\|U\|_{Z^{M+1}}<\rho\right\}$, where $\rho<\eta$ is a sufficiently small positive number subject to conditions specified later. By Lemma 4.3 (iii),

$$
\begin{equation*}
\|G(W, w)\|_{M-1, Q} \leqq \bar{\sigma}_{1} \max \left\{\|W\|_{M-1, \mathrm{Q}}^{2},\|w\|_{\mathrm{M}-1, \mathrm{Q}}^{2}\right\} . \tag{6.3}
\end{equation*}
$$

By Lemma 4.2 (ii), for $j=1,2$,

$$
\begin{align*}
\| G\left(W_{1}, w\right)-G\left(W_{2}, w\right) & \|_{M-j, Q} \\
& \leqq \bar{\sigma}_{1+j} \max \left\{\left\|W_{1}\right\|_{M-j, Q}\right. \\
& \left.\left\|W_{2}\right\|_{M-j, Q},\|w\|_{M-j, Q}\right\}\left\|W_{1}-W_{2}\right\|_{M-j, Q} \tag{6.4}
\end{align*}
$$

In virtue of (5.10), we further have

$$
\begin{equation*}
\left\|\mathrm{A}^{-1} g\right\|_{\mathrm{Z}^{M+2-j}} \leqq \tilde{\sigma}_{\mathrm{M}-j}\|g\|_{\mathrm{M}-j, \mathrm{Q}}, \quad j=1,2 . \tag{6.5}
\end{equation*}
$$

By this inequality with $j=1,(6.2)$, and (6.3), we get

$$
\begin{aligned}
\|\Xi(\mathrm{U})\|_{\mathrm{Z}^{M+1}} & \leqq \tilde{\sigma}_{M-1}\left(\left\|G\left(\mathrm{~J}_{x}^{2} \mathrm{U}, w\right)\right\|_{\mathrm{M}-1, \mathrm{Q}}+\left\|f^{*}\right\|_{\mathrm{M}-1, \mathrm{Q}}\right) \\
& \leqq \tilde{\sigma}_{\mathrm{M}-1}\left(\tilde{\sigma}_{1} \max \left\{\rho^{2}, \eta^{2}\right\}+\hat{\kappa} \eta+\varepsilon\right) \\
& \leqq \rho
\end{aligned}
$$

as soon as

$$
\begin{equation*}
\tilde{\sigma}_{M-1}\left(\bar{\sigma}_{1} \max \left\{\rho^{2}, \eta^{2}\right\}+\hat{\kappa} \eta+\varepsilon\right) \leqq \rho . \tag{6.6}
\end{equation*}
$$

By (6.4) with $j=1$, we have
$\left\|\Xi\left(\mathrm{U}_{1}\right)-\Xi\left(\mathrm{U}_{2}\right)\right\|_{\tilde{Z}^{M+1}}$

$$
\begin{aligned}
& \leqq \tilde{\sigma}_{M-1}\left\|G\left(J_{x}^{2} U_{1}, w\right)-G\left(J_{x}^{2} U_{2}, w\right)\right\|_{M-1, Q} \\
& \leqq \tilde{\sigma}_{M-1} \vec{\sigma}_{2} \max \{\rho, \eta\}\left\|U_{1}-U_{2}\right\|_{z^{M+1}}
\end{aligned}
$$

for any $U_{1}, U_{2} \in B$. If (6.6) and

$$
\begin{equation*}
\tilde{\sigma}_{M-1} \tilde{\sigma}_{2} \max \{\rho, \eta\}<1 \tag{6.7}
\end{equation*}
$$

are satisfied, then $\Xi$ is a contraction on $B$ and thus there is $U \in B$ satisfying $\mathrm{U}=\boldsymbol{\Xi}(\mathrm{U})$, i.e.

$$
\begin{equation*}
\mathrm{AU}=-\mathrm{G}\left(\mathrm{~J}_{x}^{2} \mathrm{U}, w\right)+f^{*} \tag{6.8}
\end{equation*}
$$

On the other hand $u \in H^{M}(Q) \subset Z^{M}$ satisfies (6.1). Subtracting (6.8) from (6.1) and using (6.5), and (6.4) both with $j=2$, we get

$$
\begin{aligned}
&\|u-\mathrm{U}\|_{z^{M}} \leqq \tilde{\sigma}_{\mathrm{M}-2} \| \mathrm{G}\left(\mathrm{~J}^{2} u, w\right)-\mathrm{G}\left(\mathrm{~J}^{2} \mathrm{U}, w\right) \|_{\mathrm{M}-2, \mathrm{Q}} \\
& \leqq \tilde{\sigma}_{\mathrm{M}-2} \bar{\sigma}_{3} \max \left\{\|u\|_{\mathrm{z}^{\mathrm{M}},}\|\mathrm{U}\|_{\mathrm{z}^{\mathrm{M}},}\|w\|_{\mathrm{M}-2, \mathrm{Q}}\right\}\|u-\mathrm{U}\|_{\mathrm{z}^{M}} \\
& \leqq \tilde{\sigma}_{\mathrm{M}-2} \bar{\sigma}_{3} \max \{\eta, \rho\}\|u-\mathrm{U}\|_{\mathrm{z}^{\mathrm{M}}}
\end{aligned}
$$

which in case

$$
\begin{equation*}
\tilde{\sigma}_{M-2} \bar{\sigma}_{3} \max \{\eta, \rho\}<1 \tag{6.9}
\end{equation*}
$$

implies $u=\mathrm{U}$. Thus $u \in \mathrm{Z}^{\mathrm{M}+1}$ which, in particular, yields $\partial_{x}^{\alpha} u \in \mathrm{~L}^{2}(\mathrm{Q})$ for $|\alpha|=M+1$. Since $\eta, \varepsilon$ and $\rho$ can be taken so small to satisfy (6.6), (6.7), (6.9) and all the above inequalities they are subjected to the proof of Theorem 2.1 is complete.
